**This is a general letter reminding all potential claimants of eligible sites that the PECFA program is scheduled to end in just under two years, on June 30, 2020, as authorized under Wis. Act 55 (2015).**

As the end of PECFA approaches, the DNR offers these important reminders:

- **Timely claim submittal.** Claimants and consultants planning to seek reimbursement for costs incurred on PECFA-eligible projects are reminded that they have 180 days from the day the expense was incurred, **but no later than June 30, 2020**, whichever occurs first, to submit the claim to the DNR. - **Reaching the finish line.** By now, all PECFA-eligible sites should have an approved remedial action plan in place and be actively implementing remedial action (if not already complete.) Eight rounds of quarterly groundwater monitoring are required unless otherwise directed for case closure. Currently there are only eight quarters left remaining in the PECFA program.


