Hello Mark,

I reviewed the Soil Excavation Report and Post Remedial Groundwater Report for the Frei Oil site that was received on April 20, 2020.

Here some comments:

The boring log for MW-2R should be prepared using WDNR form 4400-122.

The completed well development form (4400-113b) for MW-2R was not included.

Buried utilities should be shown on the maps.

For example, the bulk fuel storage area excavation was stopped in the area of residual soil contamination due to a storm sewer, but the storm sewer was not shown on the map.

A soil excavation map should also show locations of all soil sample locations/borings.
