Dear Mr. Moll:

On behalf of the Westbrook Delaware Limited Partnership, KPRG and Associates, Inc. (KPRG) is submitting this summary of the groundwater injection at the Westbrook Shopping Center. This injection was to supplement the prior injections and prepare the site for closure. The injection took place near MW-6 and MW-7 shown on Figure 1. The injection work was performed by ORIN Technologies, LLC starting on July 5 and completed on July 7. The work was performed in accordance with the previously approved work plan and as summarized below.

Approximately 100 gallons of a 12% ABC+ treatment chemistry were allocated for the eight injection points in the vicinity of MW-7 and approximately 200 gallons of the same treatment chemistry was allocated for the twelve injection points near MW-6. Points were spaced approximately 10 feet apart in both locations, with adjustments to avoid utilities. The number of injection points in the vicinity of MW-6 was adjusted from 12 to 11 and the chemistry was made up over nearby points. The injection interval in the vicinity of MW-7 was from 15 to 25 feet below ground surface and for injections near MW-6 was 11 to 21 ft below ground surface. At the completion of each injection point, the borehole was abandoned with bentonite and the surface was repaired.

Subsequent groundwater monitoring will occur beginning in the 4th quarter of 2022. Groundwater monitoring results will be submitted once available.

The Westbrook Delaware Limited Partnership and KPRG appreciate the constructive relationship and dialogue with the WDNR regarding this site. We look forward to continue working cooperatively in moving this site forward to obtain closure. If there are any questions, please contact me at 262-781-0475.
