NOTICE OF VIOLATION

The Department of Natural Resources has reason to believe that Kaiser Properties Trust is in violation of s. 292.11, Wis. Stats., which states, "A person who possesses or controls a hazardous substance which is discharged or who causes the discharge or a hazardous substance shall take the actions necessary to restore the environment to the extent practicable and minimize the harmful effects from the discharge to the air, lands or waters of this state."

Milwaukee Metropolitan Sewerage District (MMSD) authorized an "Initial Phase II Environmental Site Assessment" which was completed by HNTB Corporation and submitted to on April 28, 2000. This assessment involved sampling and analysis of groundwater and soil on the property you own at 4763 N. 32nd Street in the City of Milwaukee. The Department did not receive a copy of this report until May, 2002.

Ethylbenzene, xylenes, and toluene were found in soil above the NR 720 Table I standards. Diesel Range Organics (DRO) and Gasoline Range Organics (GRO) were found in soil above the generic residual contaminant levels (RCL) found in s. NR 720.09(4), Wis. Adm. Code. Phenanthrene, a polycyclic aromatic hydrocarbon (PAH), was found in soil above the suggested RCL for groundwater pathways. Lead was found in soil above the NR 720, Table 2 standards.

Preventive action limits (PALs) were exceeded in the groundwater sample for barium and cadmium. The enforcement standard for chromium was exceeded in the groundwater sample.

A responsible party letter was sent to you by the Department on May 9, 2002 and arrived at your office on May 13, 2002. This letter required that you submit written verification that you have hired an environmental consultant within 30 days. Our office has not received this verification. This consultant would develop and submit a workplan and schedule for the investigation of the degree and extent of contamination on your property.

The Department is authorized to seek forfeitures of up to \$5,000 for each day of violation.
