



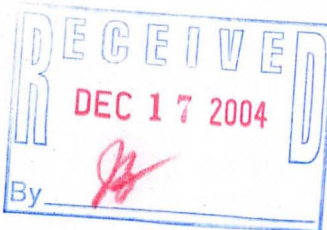

Thank you for meeting with the Department on December 14, 2004 to discuss the ongoing issues at the Bishop's Creek Development Corporation property. A summary of the key items discussed during the meeting includes the following:

- Buildings that posed a hazard have now been raised. Remaining buildings will be incorporated into the development plan or may be raised at a later date.
- Barrels and miscellaneous sized containers have been staged. The process of characterizing the waste and preparing the waste for proper shipment and disposal has begun. The issue of transformers will be addressed as the development progresses.
- Bishop's Creek is in the process of obtaining various funding to assist in the clean-up and development of the property.
- A workplan (Scope of work) addressing site remediation will be submitted in early February of 2005.
