

The public notice requirement for the Record of Decision (ROD) Amendment was met by placing a notice in the Wausau Daily Herald for three days (May 9, 11, and 13) and by posting a notice at the Marathon County Public Library during the period May 9 – June 9. Copies of the relevant documents were also placed at the library, as it serves as the information repository for the site. During the public comment period, which lasted from May 9 – June 9, no comments were received.

The Holtz & Krause Landfill Steering Committee also held a public meeting, which was advertised in the Wausau Daily Herald on June 4 and June 11. There were no attendees from the public at the meeting.

The lack of response during the public participation components indicates low interest in the site, and/or that the proposed changes to the site remedy are not controversial.
