Dear Mr. Buck:

Detailed Department review of this case over the past couple months brought an issue to our attention regarding the location information in our Bureau for Remediation and Redevelopment Tracking System (BRRTS). The location information provided to the Department at the time this release was reported in 1985 included an address of "North Meade Street". The address of "831 North Meade Street" is listed in reports for this case.

Review of current property boundaries, addresses and ownership information available on the Outagamie County GIS Website reveals the following:

- The property that includes the source area basement and collection trench to the north along with MW-17 and MW-17A (and former geoprobe wells, GMW-08 through GMW-11) is owned by Luvata Appleton, LLC and addressed as 908 North Lawe Street. The parcel number is 311114500;
- The property that includes MW-1, MW-2, MW-2A, MW-5, MW-5A, MW-18 and MW-18A (and former geoprobe wells, GMW-01 through GMW-04) is currently owned by Appleton Papers, Inc. and addressed as 714 East Hancock Street. The parcel number is 311113900;
- Multiple releases are tracked in BRRTS under the address of 908 North Lawe Street under the Activity names of "Valley Cast", "Outokumpu Copper Valley Cast" or simply the address of "908 North Lawe Street".
- One spill is tracked in BRRTS under the address of 714 East Hancock Street under the Activity name of "EOG Environmental Inc".

As a result of this information, the Department is changing the location address for this release to 908 North Lawe Street. Future correspondence should reference the following:


Future Operation and Maintenance (O&M) reports should discuss the history of ownership and property boundaries for both parcels. O&M report figures should clearly indicate current property boundaries and property ownership for clarification.

Historical soil data reveals that soil contamination was present on property currently addressed as 714 East Hancock Street, in the area of MW-5 and MW-5A. Since this is a small area of

contamination in comparison to the primary source area of the basement and north of the basement, the Department will continue to track the source area at 908 North Lawe Street. At the time of closure, both properties will need to be included on the soil and/or groundwater GIS Registry if residual contamination remains. As a result, resampling of soils in the areas of previous exceedances of soil standards should be considered prior to requesting closure to determine if it is appropriate to include both properties on the soil GIS Registry at the time of closure.
