Hi All,

As per our discussion today, I've attached EPA's residential soil UU/UE numbers, which are based on a 10^-6 lifetime cancer risk OR hazard index of 1 depending on which is more stringent, for all contaminants and highlighted PCE, TCE, and DCE. The RSL calculator was used on November 2023, but should be up to date for all of the contaminants found in the Site's RI that could be above UU/UE. As far as which contaminants to use in the UFP-QAPP, please use those contaminants listed in the SVE cleanup table for now. Also to reiterate, whatever legal standards Jeff P. sends will likely be appropriate if they are more stringent than EPA's standards, but this might not be the case for UU/UE determination.
