I have received feedback from the City.

The City would like to request a complete shutdown and abandonment of CW3. The reason for the abandonment preference is the economic impact to bring this well and pumphouse up to code. We would likely need to put about \$600,000 into this site to make it a long term well for the city. In addition this is the only well we have on the east side of the river and if we abandon this well we would be able to eliminate a raw water line under the river, which is well past its design life and extremely costly to replace. Previous lines replaced under the river for wastewater were in excess of \$1.5 million each. Eliminating and abandoning this CW3 is in the best interest of the city.
