Dear Ms. Dorman,

We are writing to notify the Wisconsin Department of Natural Resources (WDNR) of a planned July 2021 quarterly groundwater monitoring event for the Milwaukee Die Casting Company Site ("Site"). This letter is being submitted on behalf of Pharmacia LLC (Pharmacia), which is acting on behalf of Fisher Controls International, Inc. (Fisher) in this matter.¹

The groundwater monitoring event will be conducted in July 2021 to maintain a quarterly sampling schedule for the purpose of continuing to advance the Site towards WDNR closure. The July 2021 event will be the fourth consecutive quarterly sampling event.

The July 2021 sampling event is being conducted during WDNR's ongoing review of the May 11, 2021 *Supplemental Site Investigation Report* and the June 15, 2021 *Additional Groundwater Investigation Work Plan and Groundwater Monitoring Plan* ("Plan"). The WDNR communicated to Pharmacia in a June 2021 conference call that WDNR's current schedule is to complete a combined review of these submittals within 60 days of the date of the Plan or by approximately August 14, 2021.

Unless the WDNR reviews and approves the Plan before the event begins, the July 2021 groundwater monitoring event will be conducted consistent with the April 2021 event. Each of the existing 14 groundwater monitoring wells (MW-1 through MW-14) and three (3) piezometers (PZ-1, PZ-2 and PZ-10) will be sampled. The groundwater samples will be analyzed for volatile


organic compounds (VOCs), 1,4-Dioxane, ethane, ethene, methane and total organic carbon. Sampling procedures will be consistent with the WDNR-approved November 12, 2019 *Updated Site Investigation Work Plan*.
