Dear Mr. Lentz:

You have failed to comply with the terms of Special Order #2A-84-1245, issued to you by the Department of Natural Resources. You have failed to comply with the following terms:

- 1. That you remove and properly dispose of the drain tile and contaminated soils as identified in the March 12, 1985 and November 7, 1985 reports of Twin City Testing and Soil Exploration Co.
- 2. That you install approved temporary filtering devices on all private water supplies as a temporary measure while a permanent replacement is found.
- 3. That you provide the Department with a plan of corrective action to restore the contaminated groundwater by November 19, 1985.

Pursuant to the provisions of Section 144.98, Stats., the Department is immediately referring the matter to the Office of the Attorney General for further legal action to insure the objectives of the state laws are achieved. Any questions regarding this referral should be directed to Mr. Charles Verhoeven, District Environmental Enforcement Specialist, 715/839-3752.

On the morning of October 29, 1985 I contacted John O'Brien, an attorney representing Federated Insurance Company in the Lentz Fertilizer, Inc. case.

I informed him that deadlines for two requirements contained in order number 2A-84-1245 would expire on October 30 and 31, 1985.

Those requirements are: By October 30 submit a report which indicates the degree of contamination and predicted direction of contaminant movement beneath Rusk; and by October 31 install activated carbon filtration systems on all water supplies in Rusk that are impacted by herbicide.

I informed Mr. O'Brien that I had a telephone conversation with Al Rechnagel of Soil Exploration Company late in the week of October 14 or eary in the week of October 21 regarding the above deadlines. At that time, Mr. Rechnagel informed me that he expected to have a report to WDNR addressing the above items by Thursday, October 24 or Friday, October 25. That report was also to have contained a proposal for investigation of the feasibility of replacing contaminated water supplies with individual private wells.

Mr. O'Brien stated that he would contact Mike Hatampa at Federated Insurance to find out the status of those reports.

A short time later, Mr. O'Brien called me back and stated that Mr. Hatampa was not in but he had contacted Jerry Rick, Al Rechnagel's supervisor at Soil Exploration Company who would call me shortly.

When Jerry Rick called me, I informed him of the above conversations. He indicated that he had not seen the report cross his desk.

As Al Rechnagel's supervisor, he stated he would have received the document before it left SEC's office.

Mr. Rick stated that Mr. Rechnagel has an extremely heavy work load and would not be back to the office until October 31. Mr. Rick stated that he would assign another engineer to lead the project with Mr. Rechnagel remaining in an advisory capacity. Mr. Rick asked for a deadline extension until November 7, 1985.

I told Mr. Rick that I do not have the authority to grant an extension to a Department order but would discuss the matter with John Paddock and Charles Verhoeven. I told Mr. Rick that I would call him and John O'Brien and let them know the results of our discussion.

The consensus of the discussion between Paddock, Verhoeven, and myself was to have Mr. Verhoeven prepare a referral package and forward it through the Bureau of Legal Services to the Attorney General's office.

If continuing progress is made in complying with the order, an actual lawsuit may not have to be filed to satisfy the order. If satisfactory progress is not attained, no further time will be lost in gaining compliance through the courts.

Mr. Rick and Mr. O'Brien were called and informed of the decision. Both indicated a willingness to comply with the order and avoid any penalties.

Dear Mr. O'Brien:

Thank you for keeping me up to date with your involvement in the Lentz Fertilizer Inc. matter. We have no objections to providing a copy of Jim Boettcher's list to Mr. Muza. There are two clarifications I would like to make in the conversation summary of your letter to Mr. Muza.

I would like to point out that the testing and exploring is being done only by Twin City Testing. The DNR ordered investigative work to be done by Lentz Fertilizer Inc. who in turn hired Twin City Testing. The DNR will approve or deny plans to correct the pesticide contamination problems at Rusk based on the results of the investigation, its experience in these matters, and adherence to state statute and Wis. Adm. Code.

I believe its important to note that the Lentz order contains a number of conditions to be met and specific dates, and all of these conditions are expected to be attained. An apparent lack of communication between Lentz Fertilizer Inc., Federated Insurance, Twin City Testing, and Soil Exploration resulted in some delays earlier this year. Modifications to the Lentz Order have been proposed that will provide additional time to complete further investigation. When these modifications are approved, the order will allow Lentz Fertilizer Inc. to explore the possibility of drilling individual wells to provide water for Rusk residents. The DNR was not satisfied that the order was being followed but we are hopeful that investigative work will now progress rapidly at Rusk.

Your letter of August 15, 1985 to Federated has been forwarded to me as I am assisting Federated in the handling of Lentz Fertilizer matters.

First of all, I would like to advise you that Federated and Lentz have been working with the following representatives of the Wisconsin DNR:

In turn, the DNR representatives have been working with Twin City Testing Laboratories.

I had a fairly lengthy conversation yesterday, September 4th, with Mr. Verhoeven of the DNR and indicated to him the following:

- 1. I am advised that Federated has agreed to afford coverage (subject to the limits of insurance set forth in its policy) for the property damage claim now being asserted by the DNR which, in turn, seems to be seeking a solution to the problem. Again, the DNR and Twin City Testing are working towards a solution to remedy the "alleged water problem."
- Mr. Verhoeven indicated that his group and Twin City Testing are seeking some solution. At this point, we primarily have the DNR and Twin City Testing doing tests and exploring different alternatives.

- 3. Mr. Verhoeven has indicated, as of yesterday, that at least at the present time, the DNR seems satisfied with what Twin City Testing is doing and again the two groups, Twin City Testing and the DNR, seem to work well together.
- 4. I have indicated to Mr. Verhoeven that my involvement at the present times includes the probable commencement of an action against the suppliers of the chemicals, seeking, of course, indemnification or other relief under the doctrine of strict liability, failure to warn, etc.
- 5. I have indicated to Mr. Verhoeven that I have another involvement in the matter that involves endeavoring on the part of Lentz and Federated to bring some other insurers into the picture. We have information that Lentz, in earlier years, was covered with one or two other insurance companies and our office is commencing an action to try to force these other insurers to participate in the potential solution to the problem.

I would like to have from you a list of the people that you represent and, of course, would also refer you to the three fellows from the DNR that are mentioned above.

Dear Mr. Verhoven:

As discussed with you during our meeting of Wednesday, August 7, 1985, we respectively request time extensions and modifications to those established in the above referenced order and in our request for modification of December 31, 1985. Recent developments have rendered completion of the project as originally defined impossible within the previous layed-out time frame. Below we have outline the items and estimated time frame for completion of each remaining task for this project.

Item 1: Item 1 of the original "Administrative Order" requests evaluation of the extent, magnitude and direction of movement of the contaminant plume(s) in ground water beneath Rusk and degree of soil contamination in areas used or possibly used by Lentz Fertilizer, Inc. The results of the initial investigation was addressed in Soil Exploration Company (SEC) report \$120-12681 dated March 12, 1985. Expansion of the investigative efforts aimed at definition of contaminant plume(s) and soil contamination was requested by the Wisconsin Department of Natural Resources (WDNR) in their letter of April 25, 1985. The WDNR has requested additional administrative items listed above. This work will include, drilling soil test borings, installing monitoring wells, field sampling, chemical analyses and report preparation. We estimate that about 60 days from the start of initial field activities will be required to complete this second phase of investigation. We anticipate mobilizing to the site to begin enactment of field activities on or about August 19, 1985.

Therefore, we respectively request that the original deadline be modified to be "completed on or prior to October 18, 1985".

Items 3 and 6: These items of the original order deal with, in part, excavation of contaminated soils. Logistics problems during initial site work resulted in all work not being completed. In additional, more extensive field investigation of potentially contaminated area has been requested by the WDNR, which will be addressed through the work discussed above. No specific date was specified in the original "Administrative Order". At this time, further excavation work can not be undertaken as crops have since been planted in most areas where excavation will be required. For this reason, we request that the portions of the administrative order be dealing with time frames for site excavation be modified to read, "This construction season or prior to December 1, 1985".

Item 6: The final requested modification of the "Administrative Order" deals with the portion of the order which refers to the "permanent replacement of contaminated water supplies and supplies threatened by contamination". The original feasiblity study, submitted by Short-Elliott-Hendrickson, Inc. deals with an alternate supply consisting of a centralized system. Since the submittal of this plan impending public opposition has rendered a centralized system unattractive from a logistics standpoint, and potentially from ultimate settlement standpoint. For these reasons, we wish to explore the technical feasiblity of supplying individual water supplies (wells) to Rusk residents. We feel that a feasiblity study regarding the installation of individual water supply wells is warranted for the following reasons:

- Preliminary data suggest that individual water supplies systems can be designed which will supply herbicide free water.
- 2. If individual systems are proven technically feasible, the overall time frame for completion of the necessary installation would be much lower than for design and construction of a central water supply system.
- 3. Very preliminary cost estimates indicate that the design and construction of indidual system would be comparable to those associated with a central system.
- 4. Public acceptance of individual systems should be more easily gained than acceptance of a central system.

Determining the feasiblity of an individual water supply system will, in general, necessitate the following:

- 1. Hydrogeologic evaluation in regard to the continuity of a low hydraulic conductivity layer.
- Design and installation of at least 1, and possibly 2, pilot study wells.
- 3. Pump testing of these wells and extensive chemical analyses of the ground water discharge.
- 4. Well design based on analytical data generated.

We anticipate beginning initial work on the field portions of the expanded feasiblity study on or about August 19, 1985. Based on the general work scope outlined above, we anticipate that about 90 days will be required for final report submittal including well designs. We, therefore, respectively request that the original "Administrative Order" be modified to read, "Completed by November, 19, 1985".

Currently, bottled water is being supplied to Rusk residents as an alternate potable drinking water supply. As we understand, some concern has been expressed regarding dermal exposure to herbicide contaminants, as well exposure through ingestion. To minimize dermal exposure during the above feasiblity study, we are proposing to explore the feasiblity of supplying activiated carbon filtration units to the existing water supply systems of Rusk residents. We estimate that carbon filtration units, if technically feasible, could be installed at each Rusk residents within 30 days.

We appreciate your consideration of the "Adminsistrative Order" modification and look forward to working with you on the solution to the Rusk situation. If you have any questions regarding the above information, or if we can be of further service, please contact us.

The request for modification of item 1, item 2, and item 6 of Special Order #2A-84-1245 issued to you has been granted. The amended items in the order should read as follows:

THE DEPARTMENT OF NATURAL RESOURCES, THEREFORE, ORDERS:

- 1. That Lentz Fertilizer, Inc. retain an experienced consultant to determine the outer limits of the plume of herbicide contamination, the direction in which it is moving, and the depth of contamination in the aquifer through the installation and monitoring of appropriate monitoring wells. The required monitoring wells should be installed within five days of the active date of this order. A report which indicates the degree of contamination and predicted direction of movement shall be submitted to the Department of Natural Resources by Februrary 28, 1985. This report shall also indicate the extent or magnitude of soil contamination in the areas used by Lentz Fertilizer, Inc.
- 2. That Lentz Fertilizer, Inc. build suitable secondary containment around its herbicide and storage tanks in the Town of Red Cedar. These containment structures shall be lined with an impermeable barrier to prevent the downward movement of spilled product and shall have at least the capacity to contain completely the contents of the largest tank onsite. The containment structure shall be completed and operational by April 30, 1985, or prior to application periods, whichever is first.

6. That Lentz Fertilizer, Inc. shall retain an experienced consultant to develop and submit to the Department of Natural Resources for its approval, a plan for the cleanup and restoration of herbicide contaminated groundwater and soil in the community of Rusk, and for the permanent replacement of contaminated water supplies and all water supplies threatened by contamination. This plan shall be submitted to the Department by April 30, 1985 and work begun within 30 days after this Department notifies Lentz Fertilizer, Inc. of the plan's approval.

All other provisions of Special Order #2A-84-1245 will remain in effect as stated.

This modified order replaces all previous orders issued to Lentz Fertilizer, Inc.. If you have any questions regarding this letter, or the order, please call Charles Verhoeven, District Enforcement Specialist, at 715/836-2046.

As discussed with you during our meeting of December 28, 1984 we respectively request that amendments be made to some of the dates and deadlines established in the above referenced administrative order.

Item 1 of the above order refers to hydrogeologic evaluation of the site. This evaluation should entail evaluation of the direction of movement, lateral distance, thickness and predicted future movement of a contaminant plume potentially originating at the Lentz Facility. This evaluation shall also indicate the extent and degree of soil contamination in areas used or possibly used during the coarse of Lentz's operations. The original order dictates that the hydrogeologic evaluation be completed by January 30, 1985. We request that this deadline be extended to on or about February 28, 1985 for the following reasons.

- Soil Exploration Company, authorized consultant for Lentz Fertilizer and Federated Insurance Company, did not receive the "order" until December 14, 1984, and, therefore, has had limited response time.
- 2) The upcoming field work for hydrogeologic evaluation will entail about a two week time frame for completion.
- 3) The evaluation will also entail extensive chemical analyses of soils and ground water which will require at least a four week turnaround time for completion.

Item 2 of the administrative order refers to the construction of "suitable secondary containment around its herbicide and storage tanks which shall be completed and operational by April 1, 1985." We respectfully request that this deadline be extended to on about April 30, 1985 or prior to application periods. This request is made primarily due to technical difficulties and high costs associated with construction during snow cover and frozen soil conditions.

The final requested modification pertains to Item 6 of the order which refers to "a plan for the cleanup and restoration of herbicide contaminated ground water and soil in the community of Rusk, and for the permanent replacement of contaminated water supplies threatened by contamination". The order dictates that this plan be submitted by April 1, 1985. Design and preparation of the forthcoming plan will be based primarily upon information generated during the site hydrogeologic evaluation, which we anticipate will be completed as stated above. If completed on February 28, 1985, only about a 31 day time frame will remain for completion of a rather detailed design plan. Therefore, we respectfully request that the April 1, 1985 deadline for Item 6 be extended to on or about April 30, 1985. In addition, bottled water is currently being supplied to threatened Rusk residents. This has effectively removed the immediate health risk. Bottled water, or an approved alternate, will be made available until a permanent solution to the water supply problem is operational.

We appreciate your consideration of the above Administrative Order modification and look forward to working with you on the solution to the Rusk situation. If you have any questions regarding the above information, or if we can be of further service, please contact us.

The Order requires you to replace private water supplies which have been contaminated with herbicides, and make corrections to ensure future safety.

If a public hearing on this Order is desired, a written request for a hearing must be submitted to the Secretary of the Department no later than 30 days after the date this Order is served.

FINDINGS OF FACT

THE DEPARTMENT FINDS THAT:

- l. Lentz Fertilizer, Inc., is a retailer and commercial applicator of fertilizers and herbicides. The company is located in the community of Rusk, in the NW 1/4 of the SW 1/4 of section 15, T28N, R12W. The company has several types of applicators, pumps, and tanks for storage and mixing of herbicides and fertilizers. Don Lentz, owner, president, and operator of Lentz Fertilizer, Inc., routinely handles herbicides and fertilizers as part of his day-to-day operation. The company mixes and spreads herbicides and fertilizers for agricultural use.
- 2. The unincorporated community of Rusk in the Town of Red Cedar has a population of approximately 75 persons. All water is supplied through private water systems. Soils in the area are predominantly sand, sandy loam, and some gravel. The water table in this area is generally 15-20 feet deep. The private wells in Rusk are shallow, generally 20-40 feet in depth. Both driven and drilled type wells are in use.
- 3. The coupling and uncoupling of hoses to transfer liquid fertilizers and herbicides from tank to tank have caused numerous small spills to occur on the Lentz Fertilizer, Inc., property. There is a lack of adequate containment facilities and impermeable barriers to prevent fertilizers, herbicides, and wash water from entering the soils and groundwater. Lentz Fertilizer, Inc.'s vehicles, used for the transport and spreading of fertilizers, are washed near the office buildings. A drain is installed into the soil near the south edge of the property for draining excess surface water runoff.
- 4. A sample taken from the well at Lentz Fertilizer, Inc., on May 29, 1984, as part of a statewide groundwater survey, detected several herbicides, including Alachlor (Lasso), Metolachlor (Dual), Butylate (Sudan-Plus), and Atrazine (Aatrix). State health advisory limits have been set for Alachlor, Metolachlor and Atrazine: Alachlor, 10.0 ug/l; Metolachlor, 2.5 ug/l; and Atrazine, 215.0 ug/l. The amounts of Alachlor and Metolachlor in the water taken from the Lentz Fertilizer well exceeded state health advisory limits. The results of this test prompted sampling of additional wells in the area. Twenty-eight wells in Rusk were tested between May 29, 1984 and October 12, 1984; 24 of these wells showed at least one herbicide at the time of testing. Twelve of these wells had Alachlor, Metolachlor, or both in amounts at or above health advisory limits.

- 5. The results of a water table survey conducted on October 11 and 12, 1984 by the Department of Natural Resources indicated the groundwater is moving from east to west through the community of Rusk, which means that the contaminated wells are downgradient of the Lentz Fertilizer, Inc., property.
- 6. Six wells outside the community of Rusk were also sampled. All of these wells were located not more that 1/2 mile from Rusk, and generally surrounded Rusk. There was no herbicide contamination detected in any of these wells.
- 7. The Department has determined that Lentz Fertilizer, Inc., is responsible for the groundwater contamination in the unincorporated community of Rusk in the Town of Red Cedar, and has rendered all of the private water supplies in Rusk unfit for human consumption because all of the wells are either contaminated with herbicides or threatened with imminent contamination.

CONCLUSIONS OF LAW

THE DEPARTMENT CONCLUDES THAT:

- 1. Alachlor, Metolachlor, Butylate and Atrazine, the herbicides which have contaminated the groundwater in the community of Rusk, Town of Red Cedar, Dunn County, are "hazardous substances" as that phrase is defined in section 144.01(4m), Wisconsin Statutes.
- 2. Lentz Fertilizer, Inc., had possession of, and control over, these herbicides before they were discharged and has responsibility under section 144.76(3), Wisconsin Statutes, to take the actions necessary to restore the environment to the extent possible, and to minimize the harmful effects from any discharge to the air, land, or waters of the state.
- 3. Section 144.76(7)(b), Wisconsin Statutes, requires the person who possessed or controlled the hazardous substance which is discharged, to reimburse the Department of Natural Resources for actual and necessary expenses incurred in carrying out its duties under section 144.76(7)(a), Wisconsin Statutes.
- 4. The Department of Natural Resources has the authority under section 144.76(7)(c), Wisconsin Statutes to issue emergency orders or special orders for the protection of public health, safety, or welfare.
- 5. Under section 144.265, Wisconsin Statutes, the Department of Natural Resources has the authority to order the owner or operator of a regulated activity to replace contaminated private water supplies which it has caused to become contaminated.

ORDER

THE DEPARTMENT OF NATURAL RESOURCES, THEREFORE, ORDERS:

1. That Lentz Fertilizer, Inc., retain an experienced consultant to determine the outer limits of the plume of herbicide contamination, the direction in which it is moving, and the depth of contamination in the aquifer

through the installation and monitoring of appropriate monitoring wells. The required monitoring wells should be installed within 5 days of the effective date of this order. A report which indicates the degree of contamination and the predicted direction of movement shall be submitted to the Department of Natural Resources by January 30, 1985. This report shall also indicate the extent and magnitude of soil contamination in the areas used by Lentz Fertilizer, Inc.

- 2. That Lentz Fertilizer, Inc., build suitable secondary containment around its herbicide and storage tanks in the Town of Red Cedar. These containment structures shall be lined with an impermeable barrier to prevent the downward movement of spilled product and shall have at least the capacity to contain completely the contents of the largest tank onsite. The containment structures shall be completed and operational by April 1, 1985.
- 3. That Lentz Fertilizer, Inc., remove the drain originating on the south edge of its property, and remove any herbicide-contaminated soils associated with that drain.

- 4. That Lentz Fertilizer, Inc., install a catch basin to collect and contain rinse water from tank cleaning and equipment filling operations, by April 1, 1985. Any material collected in this basin shall be disposed of immediately in accordance with the instructions found on the label of the herbicide being handled.
- 5. That Lentz Fertilizer, Inc., shall dispose of all herbicide containers in the manner described on the container label.
- 6. That Lentz Fertilizer, Inc., shall retain an experienced consultant to develop and submit to the Department of Natural Resources for its approval, a plan for the cleanup and restoration of herbicide contaminated groundwater and soil in the community of Rusk and for the permanent replacement of contaminated water supplies and all water supplies threatened by contamination. This plan shall be submitted to this Department by April 1, 1985 and work begun within 30 days after this Department notifies Lentz Fertilizer, Inc., of the plan's approval.

- 7. That Lentz Fertilizer, Inc. supply safe and adequate temporary alternative water supplies to all residents and businesses in the community of Rusk, Town of Red Cedar beginning no later than five days after the effective date of this order until a permanent water supply is in place. Residents and businesses to be supplied with water are listed on Exhibit A, attached hereto and made a part hereof.
- 8. The Department of Natural Resources retains jurisdiction to amend this order if such action is necessary for the protection of public health, safety, or welfare.

NOTICE OF APPEAL RIGHTS

This order shall be effective 30 days after it is served, unless Lentz Fertilizer, Inc., submits a petition for a hearing to the Secretary of the Department of Natural Resources within that 30-day period. If a hearing is

requested, this order shall not become effective until after the hearing is concluded and the hearing examiner has issued a decision affirming or modifying the order. This notice is provided pursuant to section 227.11(2), Wisconsin Statutes.

EAU CLAIRE -- Owners of 27 wells in the rural Dunn County unincorporated community of Rusk today are to receive notice from the Department of Natural Resources to discontinue drinking water from their wells because of herbicide contamination.

All wells in the community are affected by the notice. Rusk is located about two miles northeast of the City of Menomonie.

Residents are being advised to use bottled water or secure water from sources that are known to be safe. Additional information about health concerns will be available from the Dunn County Public Health Nurse.

The letter sent to residents and landowners says in part,

"Due to the widespread occurrence of herbicide contamination in Rusk
and the close proximity of individual wells to each other within ...

Rusk, it is the recommendation of this Department, from the standpoint
of health, that all residents of ... Rusk discontinue use of their

wells as a source of water for drinking and cooking."

The groundwater contamination was first discovered as the result of routine Department of Natural Resources monitoring. An intensified monitoring effort has revealed that 85 percent of the wells in the community show some level of herbicide.

As the result of investigations into the source of the contamination, the Department of Natural Resources will issue an administrative order to Lentz Fertilizer Inc., Rusk, under state hazardous substance spill statutes (NR 144.76) alleging that the firm spilled hazardous substances and contaminated groundwater.

Under the hazardous substance spill law any firm or individual causing such pollution is responsible for investigation and cleanup efforts.

The law says in part, "A person who possesses or controls the discharge of a hazardous substance shall take the action necessary to restore the environment to the extent practicable and minimize the harmful effects from the discharge to the air, lands, or water of the state."

The DNR order will require Lentz Fertilizer Inc. to do the following:

- install containment measures to prevent future spills;

- investigate and delineate the area that has been contaminated;
- submit to the Department of Natural Resources a remedial action plan to restore the contaminated area to its previous condition;
- provide a safe water supply for well owners and residents using affected wells in Rusk.

The herbicides discovered during the investigation, which has taken place during the past four months, are alachlor, metolachlor, atrazine, butylate, and cyanazine.

In addition, high nitrate levels were discovered in many of the wells.

Of the 27 wells affected, 20 are serving residences and four are serving businesses. The Red Cedar Town Hall well also is affected by the advisory.

The majority of the wells are driven points from 20 to 30 feet deep. The area has a high water table and sandy soils. Such water and soil conditions are typical of those often resulting in contamination of groundwater.

In addition to sampling wells in Rusk, Department of Natural Resources specialists sampled wells serving six residences near the village. No herbicides were detected in any of the wells in the surrounding area.

The well monitoring that revealed the herbicide contamination in wells at Rusk is part of an ongoing Department of Natural Resources effort to determine where groundwater problems may exist. Samples taken for testing are analyzed at the State Laboratory of Hygiene to determine herbicide concentrations.

Under Wisconsin's recently enacted groundwater protection bill individuals whose wells are contaminated with herbicides can apply for compensation Jan. 1, 1985 but claims cannot be made based on any actual construction work or well drilling that has taken place before that date. After July 1, 1985 all claims for compensation made during the first six months of the year will be added and, if claims exceed state allocations, the claims will be paid on a prorated basis.

This is a typewritten copy of a statement I took from Donald R. Lentz on 9/21/84.

I started this statement at 10:25 a.m. and completed it at 11:07 a.m. At 11:30 a.m. I asked the subject to sign the statement after I had read it back to him and he declined and refused to sign such a statement. Here then follows that statement:

Donald R. Lentz is 35 years old and has 4 years of vocational education. He provided the information to William G. Barton who is writing it down.

I, Donald R. Lentz, am owner of Lentz Fertilizer, Route 2, Menomonie and have owned this incorporated company for about 15 years or since 1971. I have about 17 employees at the peak of the season. I drive truck and am generally the only one on duty during the winter months with the exception of my bookkeeper. I do drive my own truck once in awhile. I do handle all these products like Lasso, Dual, Atrazine, Sutan+, Bladex, Eradicane, yes, I handle all of them. They come in all sizes by private carrier, liquid, powder, and granular. They come in paper bags, plastic bags, plastic cans, tin cans, plastic and metal drums. Fertilizer is the only material shipped by rail. I am a restricted use applicator and have a license issued by the State of Wisconsin. It is not required that I have an applicators license to apply the above-listed products. Firalso handle paraquat and ferridan on occasions. I didn't use any terridan and only about 70 gallons of periquat this year. I used about 3800 gallons of Lasso, 180 gallons of Dual, 4500 gallons of Atrazine, 3500 gallons of Sutan+, 150 gallons of Bladex, and about 400 gallons of Eradicane this year. I spray about 10,000 acres of farm land with all of these products. Each chemical has a different rate per acre and is mixed in my company yard. No spills or accidents that I can recall on my property have occurred. The cans are rinsed and added to the load. No waste product is involved. In order to prevent spills of any kind, I mix 80 to 90 percent of all chemicals at my place of business for the 10,000 acres of farm land that I spray. The men wear rubber goggles and rubber boots to protect themselves from spills. A truck rolled over that was owned by me and it had fertilizer (pot ash) on it. A picture was shown to me showing the site, but the tree that's dead in the scene was already dead before this fertilizer was spilled there. It was all cleaned up by me except that the soil was not removed from the scene. It was reported through the Sheriff's office. No waste material is dumped anywhere. It is used up in the fields. Basically, the only spills I have are the two quarts out of the hoses or the 1-3 gallons out of semi hoses. Preventative measures have been started to correct these problems. These disconnects amount to a lot of material being lost. About three gallons a day for about three weeks for maybe 4-5 years is what has spilled on my property since I have been handling chemicals. This is mixed material of pesticides and fertilizers for application. I am making a concrete filling area to prevent groundwater contamination and to prevent product loss. I don't wish to sign this document, was the statement of Donald Lentz at 11:30 a.m.


