SUBJECT: Monitoring Well Installation/Sampling and Soil Sampling at C.M. Christiansen Pole-Dipping Site

Dear Mr. Christiansen::

I would like to take this opportunity to thank-you for taking the time to talk with me on July 27, 1993. As we discussed, I have enclosed a copy of some information on pentachlorphenol (pcp). I obtained this information from the Department's Water Supply Program. In addition, I have attached a copy of the results of pcp testing that was done on sediments from Military Creek in September 1992.

I would also like to request your permission, Mr. Christiansen, to install three groundwater monitoring wells and take soil samples at the old pole dipping site. I anticipate the drill rig will install the wells the week of September 6, 1993. We would then return to the site the week of September 20, 1993, and take samples from these wells. At that time, we would also take four soil samples. This work would be done as part of a Superfund Site Assessment Site Inspection (SI). The work is to be performed by the State of Wisconsin Department of Natural Resources (WDNR) under a cooperative agreement with the U. S. Environmental Protection Agency (EPA).

If you would like, Mr. Christiansen, you are welcome to take split samples from any of the samples that will be collected during the week of September 20, 1993. If you are interested in split sampling with us, please let me know.

Once again, Mr. Christiansen, the well installation is scheduled for the week of September 6, 1993 and the sampling for the week of September 20, 1993. If there are any changes from that schedule, I will telephone you to let you know.

I would appreciate your written permission to proceed with the well drilling and sampling as scheduled. Please indicate your approval and permission by signing both copies of the last page of this letter as provided, and return one to me. The second copy may be retained for your records.
