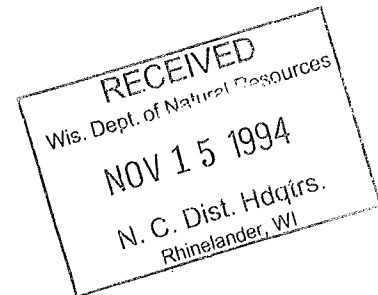

Dear Mr. Brinkmann:

The Department of Natural Resources intends to select a consultant for an environmental site investigation of the C. M. Christiansen property near Phelps, Wisconsin. Your firm has been selected by the Department's consultant selection committee to submit a statement of qualifications.

3. A description of any equipment/laboratory facilities which your firm has available for this project.
4. A list of any portions of the Scope of Work which would be subcontracted to other firms and who whose subcontractors are likely to be.
5. A statement indicating why you believe your firms would be the best qualified for this project.

Your response will be evaluated and selected firms which appear to be best qualified will be requested to submit proposals and cost estimates. Enclosed are the Scope of Work for the proposed project and a copy of the Department's standard contract language. Please submit your response no later than November 22, 1994.
