Subject: Highway 37 Waste Tire Dumpsite

Dear Mr. Koziar:

The Uniroyal-Gillette Waste Tire Stockpile Abatement Project has progressed to the point where the Highway 37 site has been removed, processed, and delivered to an end user. I determined during an inspection on September 24, 1998, that all of the waste tires that could be removed, were removed from the project site. In accordance with the state contract, Superior Special Services, Inc. is entitled to a payment at this time.

Invoices submitted to the Department by Superior Special Services, Inc. for work completed from July 27, 1998 to September 11, 1998, document that 2,730.885 tons of recyclable rubber have been removed from the project site, processed, and delivered to an end user. Product produced from processing of the waste tires has been delivered to Tenneco Packaging of Tomahawk, Wisconsin.

Superior Special Services, Inc. submitted scale receipts for the weights of waste tires removed from the project site. All loads from the project site were verified at Golden Rule Travel Plaza in Osseo, Wi. I have reviewed and verified all submitted invoices and checked all cost calculations for accuracy. Therefore, it is my recommendation that payment be made to Superior Special Services, Inc. for services provided. Payment due for the removal, processing, and delivery to an end user of 2,730.885 tons of recyclable rubber at \$98/ton, 381.26 tons of waste material at \$150/ton, erosion bale installation at \$100.80, and water removal and disposal at \$731.25 is \$ 325,647.78.

Attached is a summary of the invoices for each load of waste tires removed from the project site and a summary of each load delivered to an end user, plus an invoice voucher.
