Hi Ryan,

I reviewed the request for operation and monitoring plan amendment dated April 12, 2023. While verbal approval was granted this shall serve as written approval for the following:

- Remove MW4, MW5, MW6, MW8, MW8A, MW11A, MW12, MW12A, MW13, MW13A, MW14, MW14A, MW15 and MW15A from the groundwater monitoring plan/ schedule and abandonment as prescribed in NR812.26, WI. Adm. Code.
- Removal of sampling residential monitoring at 1070 192<sup>nd</sup> Ave.
- Change sampling frequency of MW1, MW10, MW10A, MW16, MW16A, MW17, MW17A, MW18 from a semi-annual to an annual sampling frequency.
- Change groundwater level readings from a semi-annual basis to an annual basis.
- Change monitoring landfill gas wells and select SVE (4,6,7,12,13 and 14) wells from a monthly to a quarterly frequency (April and October).
- Change VOC measurements using flame ionization detector(FID) to monitor using a photoionization detector (PID).

The above modifications to the current Operation and Monitoring Plan are approved by the DNR and any additional modifications, comment or questions can be proposed and reviewed anytime. Please feel free to reach out.

Good Morning Candace,

I emailed you the attached Request for Operating and Monitoring Plan Amendment in April and got a verbal approval from you in May for the groundwater monitoring well sampling reduction. We are tentatively planning to sample the monitoring wells the week of October 9<sup>th</sup>. I'd like to get written approval of the monitoring well reduction from you before sampling for my records. Either a letter or an email approving the proposed sampling plan would suffice.

In addition to the groundwater monitoring sampling reduction, we recommended some reductions to the landfill gas monitoring at the Site. The proposed landfill gas monitoring reductions are detailed in line items 7 and 8 on the attached PDF. Ideally, it would be great if we could implement the reduction in landfill gas monitoring before winter. Please let me know if you have any questions.
