I talked to Kelly Raleigh Moses asking who I should contact, and she gave me both of your names.


We will be doing an initial round of sampling this spring and hope to perform the abandonments late this summer or early fall.



The Wisconsin Department of Natural Resources hereby gives permission to the Wisconsin Department of Natural Resources ("the department") and its employees, duly authorized representatives, agents and contractors, to enter upon and have access at reasonable times to the Nicolet State Trail, Lakewood within NE 1/4 and NW 1/4 of Section 31, T33N, R16E, Oconto County, Wisconsin, referred to herein as the "Property", and that is owned by the Wisconsin Department of Natural Resources, for the following purposes, so that the department may:

(1) Properly abandon the groundwater monitoring wells installed at the request of the department when the wells are no longer needed.

The department is responsible for any investigative waste that is produced by these activities and will return to collect any investigative waste that may be temporarily stored on the Property.

The permission that is granted herein shall remain in effect until December 31, 2022. Before December 31, 2022, if the owner of the Property wishes to withdraw permission for continued access, the owner of the Property shall notify the department of that fact in writing. The department shall, within 90 days after receiving such notice, either cease/finalize listed activities and abandon wells, or obtain a court order to allow continued access.

The DNR's authority to access to the Property described above is provided under Wisconsin Statute § 292.31(3).
