Hi all,

Well I am so sorry to report that I am going to have to throw a large wrench into these plans to not resample. I did not realize that we at the agency had an actual PFAS group that coordinates any PFAS work. I had been following what I thought was protocol and using the state's PFAS team. So unfortunately, we are going to need to resample again — with that being said I have already been working to get everything going. The best way forward it to have a coordination call with my QAPP contact as we are going to have to do a QAPP addendum or a QAPP just for PFAS sampling. It should not be an overwhelming amount of paperwork. I am also sending our QAPP person the approved workplan and results from the sampling and our old QAPP so that we can make doing this work streamlined. If we can plan to set up a call with WDNR (and possibly a PFAS person there), TRC and SSPA in a few weeks, then we can get everything prepared to do the PFAS sampling one more time and hopefully get this completed.

Kris,

On February 9th 2022, the WDNR PFAS committee reviewed the PFAS data you submitted in November 2021 for the Lemberger sites. The committee agreed that no further PFAS sampling is needed at this time. We concluded this based on these factors;

- Only one of 33 PFAS samples was detected above the PAL, and only at one well.
- The detect occurred at the well historically associated with the highest VOC detects, directly downgradient of the site.
- Two wells further downgradient had detects, but below the PAL.
- One upgradient well had detects similar to the far downgradient wells.
- VOC concentrations are generally declining.
- 1-4 dioxane showed similar results when examined in 2012.
- The work plan was complete and executed as proposed.
- No laboratory QA/QC issues occurred.

This email should be referenced when we arrive at decision documents such as RoD amendments or closure.

Thank you for your good work on this issue. It's far easier when the work plan is clear and complete, the work is done correctly, and the communication is prompt and clear, as performed by your team on this project.
