### ACCESS PERMISSION FORM

I, Jeffrey S. Schramm, V&S Midwest, hereby give my permission to the Wisconsin Department of Natural Resources ("WDNR") and its employees, duly authorized representatives, agents and contractors, to enter upon and have access at reasonable times to the property located at 2001 Hyland Avenue, that is owned by Midwest Carriers Corp. in the City of Kaukauna Industrial Park, T21N, R18E, Outagamie County, Wisconsin, ("Property"), of which I am the legal representative or owner ("Owner"), for the following purposes:


1. To respond, as needed, to system alarms and damage to any part of the groundwater collection and treatment system or monitoring network;
2. To maintain, repair or amend the groundwater collection and treatment system;
3. To collect soil and water samples;
4. To properly abandon the soil borings, geoprobes, groundwater monitoring points and groundwater collection and treatment system when no longer needed; and
5. To gain access to areas where investigative work or remedial action is to be conducted.

The permission that is granted herein shall remain in effect until **December 31, 2012**. After December 31, 2012, if the Owner wishes to withdraw permission for continued access, the Owner shall notify the WDNR of that fact. The WDNR shall, within 90 days after receiving such notice, either abandon any wells that remain on the Property or obtain a court order to allow continued access.

When soil or water samples are collected on the Property described above, split samples will be provided to the Owner, if the Owner requests split samples and provides sample bottles before the samples are collected.

The Owner agrees not to damage or interfere with the use of any soil boring, geoprobe, monitoring well or piezometer that is installed as permitted herein, and agrees to notify third parties who plan to conduct any activity on the Property described above that monitoring wells and piezometers have been installed on the Property.
