CROSS CONNECTION CONTROL DEVICE

Our records indicate that the cross-connection control device(s) or assembly(s) listed below are past due for the periodic test by a department-registered Cross-Connection Control Device Tester. The due dates are the expiration dates listed.

A cross-connection control device or assembly is a mechanical valve that protects the potable water supply system from contamination. Since a physical connection between the potable water supply and substances of either unknown or questionable quality exists in the facilities listed below, a cross-connection control device or assembly was/is required. Each installed device or assembly must be tested at least annually to ensure that it continues to function as designed.

It is the owner's responsibility to have a performance test conducted by a department registered Cross-Connection Control device tester prior to the device or assembly being put into service and at least annually thereafter. Also, the device or assembly must be tested whenever repairs or replacements occur. Every time a test is performed, a test report must be submitted to this office.
