In accordance with Wis. Stats. § 292.81(4), the Walter Nickel Trust is hereby notified, as a responsible party under Wis. Stats. ch. 292 and Wis. Admin. Code § NR 700.03 (51), that the Department of Natural Resources ("department") intends to file a lien against the above-referenced property in order to recover costs incurred by the department related to the inspection, operation and maintenance of the landfill cover and monitoring system, and cleanup of contamination associated with the property.

From state Fiscal Years 2015 through Fiscal Year 2022, the department incurred costs in the amount of seven hundred sixty-seven thousand, nine hundred and nineteen dollars and fifteen cents (\$767,919.15). The department anticipates incurring additional costs for the completion of cleanup activities at the site. The lien will be filed on or after **August 1, 2023**.
