Hi Andrew,

I wanted to give you a heads up that the Aniwa Arsenic Site will be getting a case closure denial prior to issuing the case closure denial letter. Additional actions will be required regarding potential additional source control measures either by removal/excavation or an in-situ remediation, continued groundwater and potable well monitoring, addressing potential wetland impacts, and addressing other Direct Contact Soil RCL Exceedances beyond the capped area on-site.

The Town of Aniwa has historically stated that they have limited funding for additional cleanup at this site. Although funding sources are quite limited since the Town is the causer of the contamination, I have been looking into any potential options. I had a call with Kathy Halbur, (an EPA On-Scene Coordinator in our regional DNR office that coordinates with DNR staff for Removals) yesterday regarding potential for EPA removals assistance. In order to better assess the current status of the site and to help provide a stronger presentation when Kathy takes this to EPA for potential funding/removal assistance purposes, Kathy and myself would like to meet with you, a representative from the Town if they would like to be present, and possibly another person who has been heavily involved in this case, such as Warren Hohn.

Kathy Halbur will be in our Green Bay DNR office next week Tuesday, September 2, 2014 and available for an on-site meeting. If possible, we would like to schedule an on-site meeting at 10am on

Tuesday. Since I hadn't had a chance to talk to Kathy prior to yesterday regarding this site, sorry for the short notice. Please let me know as soon as possible if this could be arranged.
