Dear Mr. Zuleger:

On December 20, 2002 the Department of Natural Resources (DNR) issued a Final Closure letter for the above referenced site. At that time, this case was closed with continuing obligations for residual soil and groundwater contamination for the former Waugamie FS Coop. On November 18, 2016 the Department of Agriculture, Trade and Consumer Protection (DATCP) sent a letter notifying GLK Foods that the case was re-opened. This action was taken in preparation for site development as proposed in the *GLK Foods, LLC Expansion and Site Grading/Excavation Plan*, prepared by Foth and dated November 16, 2016.

Three former Coop buildings (the dry bulk fertilizer, pesticide storage, and bulk pesticide storage buildings) were subsequently removed. Based on results from an October 2016 site investigation, Foth then coordinated the excavation of contaminated soil prior to construction of the existing GLK warehouse. Soil remediation activities are documented in the *Landspreading Post Application Completion Report* prepared by Foth and dated March 2, 2021. As described in that report approximately 464 cubic yards of soil was excavated and landspread at a nearby field in accordance with a Landspreading permit issued by DATCP. Post excavation soil samples show that nitrogen remained above the clean up goal at one location.

This case was re-opened to complete the corrective action described above. DATCP considers this case closed. You and any future property owners must adhere to the requirements identified in the December 20, 2002 Final Closure Letter available at the Bureau for Remediation and Redevelopment Tracking System (BRRTS) on the Web (BOTW). This information is made available to provide public notice of residual contamination and continuing obligations. To find BOTW at dnr.wi.gov, search for "BOTW." An online map view of the site can also be found on the RR Sites Map (RRSM) at dnr.wi.gov by searching for "RRSM." All case information is also on file in the DATCP office, located at 2811 Agriculture Drive, Madison, Wisconsin.

If the case is re-opened, Agricultural Chemical Cleanup Program (ACCP) reimbursement may still be available. Determination of the ACCP eligibility of any future corrective action costs incurred at this site should be made before the corrective action is performed. It is in your best interest to keep all documentation related to the cleanup project and ACCP reimbursement applications.
