Wisconsin Public Service Corporation (WPSC) is providing this monthly progress report for the WPSC Former Green Bay Manufactured Gas Plant (MGP) Site.

**1) PROGRESS MADE DURING THE PAST MONTH**

- Prepared and submitted March 2022 Monthly Progress Report to United States Environmental Protection Agency (USEPA) by April 15, 2022.
- Submitted an updated Project Schedule April 15, 2022.
- Responded to USEPA comments/questions received April 18, 2022 regarding the April 15, 2022 Project Schedule on April 19, 2022.
- Received USEPA authorization letter to conduct a voluntary removal action at WPSC Green Bay OU1.
- Initiated preparation of *Remedial Action Work Plan (RAWP)* for a voluntary removal action at WPSC Green Bay OU1.
- Submitted *Annual Progress Report and Master Schedule* on May 5, 2022.
- Met with representatives of the City of Green Bay on May 6, 2022 to discuss the Early Removal Action.

**2) ANALYTICAL AND OTHER TESTING RESULTS RECEIVED**

- Pre-Design Investigation (PDI) soil analytical results for primary and secondary borings. Results are undergoing validation and will be submitted in the next monthly progress report.

### 3) PROJECTED WORK

#### WPSC Actions

- Submit monthly progress report to USEPA by the 15<sup>th</sup> of the month.
- Continue to evaluate and incorporate PDI data into a *PDI Data Summary Report*, which will be incorporated into the RAWP for the Early Removal Action.
- Incorporate USEPA comments on the *Supplemental Investigation Results Memo* into the RAWP for the Early Removal Action.
- Respond to comments on the *Sediment OU RI Report, Revision 1*.

#### USEPA Actions

- Prepare to receive and review the RAWP for the Early Removal Action.


