On April 26, 2022, the U.S. Environmental Protection Agency (EPA) sent an authorization for WPSC to conduct this work pursuant to Section 107(d) and 122(e)(6) of CERCLA, 42 U.S.C. §9607(d) and 42 U.S.C. §9622(e)(6). In accordance with this authorization, EPA has reviewed and provided comments on the *Early Removal Action Summary Report – Operable Unit 1 North Parking Lot – Revision 1* for the Former Green Bay Manufactured Gas Plant Site, dated November 16, 2023. EPA has no further comment. All data as part of this work will be carried into the Remedial Investigation Report for Operable Unit 1.
