Mae- Thanks for the info. Sun, Aug 12, I tried to do a "Metes and Bounds" search on Tapestry for Chippewa County using the section, township, range, and quarter section info that you provided.

- For Sec 28, T28, R09, SW: I got 460 results and the program indicated "only the first 200 will be returned."
- For Sec 33, T28, R09, NW: I got 306 results and the program indicated "only the first 200 will be returned." In both cases, that was more pages than I was prepared to wade through and I wasn't sure how I'd access the second page sets.

When I get back from vacation, I'll try again during the week of Aug 20 and contact someone at Tapestry for direction if necessary.

Meanwhile, Knight Barry Title (KBT) at 715/723-3747 indicated on Fri, Aug 10, that I can purchase a three-page legal description of the airport's tax parcel from KBT to use if that work-around will suffice.

(Follow each blue line from its origin near the runway to where the line ends, for the estimated well location.) The Public Land Survey System info for those locations is below, in case you want to search Tapestry (landrecords.net).

- MW-50 and MW-59 well nests are in Section 33, T28N, R09W, Chippewa County
- As estimated, RW-5 appears to be in S5, T27N, R09W, Eau Claire County
- RW-25 appears to be in S28, T28N, R09W, Chippewa County

I'll find out next week whether the deeds are generally required for lost well situations and what kind of work-around is acceptable if deeds are not available.
