INTERIM REMEDIAL ACTION ON-SITE GROUNDWATER PROGRESS REPORT NO. 315 SEPTEMBER 2018 NATIONAL PRESTO INDUSTRIES, INC. SITE EAU CLAIRE, WISCONSIN

This progress report is prepared and submitted in accordance with the reporting requirements contained in the Administrative Order for Remedial Action between National Presto Industries, Inc. (NPI) and the United States Environmental Protection Agency (USEPA), effective July 16, 1992.

During September 2018, a total of approximately 7.8 million gallons of groundwater was pumped from Southwest Corner extraction well EW-6, treated by cascade aeration, and then discharged to the Chippewa River via the city storm sewer. Water was pumped continuously from EW-6 all month at an approximate average flow rate of 180 gallons per minute. Southwest Corner extraction well EW-5 remained shut down.

Extraction well EW-6 and the effluent from cascade aeration are sampled quarterly. A discharge monitoring report (DMR) with analytical results for the second quarter of 2018 was submitted to the WDNR and USEPA on July 17, 2018. The next DMR with the third quarter analytical results for 2018 will be submitted in October 2018.

REMEDIAL DESIGN/REMEDIAL ACTION MELBY ROAD DISPOSAL SITE SOIL VAPOR EXTRACTION SYSTEM PROGRESS REPORT NO. 264 SEPTEMBER 2018 NATIONAL PRESTO INDUSTRIES, INC. SITE EAU CLAIRE, WISCONSIN

This progress report is prepared and submitted in accordance with the reporting requirements summarized in Section XI - Order, Paragraph 58 - Progress Reports of the Unilateral Order between National Presto Industries, Inc. (NPI), National Defense Corporation, and the United States Environmental Protection Agency (USEPA), effective October 21, 1993.

During September 2018, the soil vapor extraction system at the Melby Road Disposal Site operated continuously (except for relatively short periods [i.e., less than 1 percent of the time] when the system was temporarily shut down for condensate transfer and/or blower changeover) with one blower running all month. Data collected during the month show that the blower ran at an average flow rate of 570 actual cubic feet per minute and the manifold vacuum was steady at 3 inches of water column, when operating.
