In Dec 2018, National Presto Industries, Inc. (NPI) completed sampling select wells for analysis of perfluoroalkyl substances (PFAS) in Eau Claire, Wisconsin, at EPA's request. Lab results document that all three wells were non-detect for PFAS, as summarized in the attached Feb 2019 report.
