

#### **Property Owner Complaints/Concerns:**

- We would like to make you aware that the installed water softener due to the contaminated water is severely ruining all of our faucets, sinks, dishes, pots, pans, dishwasher and washer by leaving white residue and stains all over.
- The water smells awful and our house looks and smells awful
- We'll come home from work and the bathroom smells like an out house that hasn't been cleaned in a month, it's disgusting.
- We are concerned about the distance the well was drilled from the septic percolator; there was some concern about the distance being shorter than recommended but the engineer felt it wouldn't be a problem. Could this be a reason for the extremely smelly water?
- White stains are still prevalent and continue to stain the faucets, countertops, dishes, etc despite constantly wiping everything down.
- We cannot drink the water or cook in it due to the above reasons and it is extremely salty. We've kept the Culligan water service for these reasons and don't see an end in sight for this service.
- We are very concerned about the resale value of our house due to these issues and the potential of loss of income to us.
