Thanks for following up Disa. The last update I received was late last week from the City attorney Kathleen McDaniel. She notified me that the property owners whose wells were sampled for PFAS were provided the results. Kathleen will be having those notification letters sent to DNR. Some of the new property owners continue to experience aesthetic quality issues with some of the newer private wells that were installed due to the depth and geologic formation the wells pull water from, which results in really high total dissolved solids. The water is free of the contaminants, but has poor aesthetic quality. It is creating problems with leaving residue in sinks, bathtubs, etc. in addition to poor taste. Due to these issues, Culligan water continues to be provided to the property owners. I'm not sure what will happen next at this point because there are cost recovery negotiations currently going on between the City of Manitowoc and Newell Rubbermaid (acquired former Mirro Company) and we are supposed to receive a response from these parties by the end of this month.
