Alternate Interim Drinking Water Option

Good morning Roxanne,

I just wanted to summarize the above referenced call this morning. The City is requesting to use granular activated carbon (GAC) point of entry treatment (POET) systems for the current four private wells with volatile organic compounds (VOCs), specifically vinyl chloride, above the ES and for future ES exceedances in the interim until a permanent solution is determined and budgeted for. The City made the comments that: 1) the long term solution may or may not be municipal water based on continued sampling/investigation of private wells and 2) The City knows they need to continue sampling additional private wells to the east. The City wants to do the GAC POET to avoid future asthetic quality issues, which have been seen in four of the most recently replaced private wells, and don't want to continue pouring costs into replacement wells if the future decision will be municipal water.

The DNR agreed with this interim solution with a continuous sampling plan and proper installation, operation, and maintenance for the private wells that would be receiving POETs. DNR is having the City put together a more formal written request for this, which AECOM will prepare and submit.

Other items that were briefly mentioned. The City currently has no proposal for additional PFAS sampling. The City does want to get back to having more regular in-person status update meetings with the DNR like has been done in the past. I told the City additional PFAS sampling will be needed and we will discuss further at the next in-person meeting. As we recently told the outside council for the City (Ned Witte) and Newell's attorney (Gabriel Rodriguez) about PFAS sampling, I plan to convey the same message to the City that additional PFAS sampling needs to happen on a parallel tract with the cost recovery.

Now that Steve is retired, are we reporting this kind of information to Bart Sponseller now?

We can discuss more when you get back.
