Since you indicated your wife is now pregnant, I just wanted to also provide some good general sampling practices for your private well that is outside the scope of what the City/AECOM would be sampling for. I talked to Drinking Water DNR staff in my office and they indicated sampling is highly recommended for nitrate and bacteria. Since your wife is pregnant, the DNR staff also indicated the County may pay for the sampling costs if you do decide to sample at this time. The general number for Manitowoc County is 920-683-4000.

Hi Nick,

It is reassuring to see that your sample and the sample DNR collected both had no detections, that's great news! The other samples of other private wells (besides the Moore and Novy wells) in the area have also come back with similar findings to your results, which is also reassuring. With the two impacted wells in the area, DNR is currently evaluating as part of a larger investigation the responsibility of potential responsible parties to determine who will be doing additional sampling, well replacement, etc. DNR is still looking to potentially conduct some additional sampling of a couple properties that haven't been able to get sampling scheduled with DNR yet and potentially some confirmation sampling. Once it has been determined who is responsible for the contamination, that party will need to come up with a sampling plan to ensure the public remains protected. Until that time, I won't be able to give you a definitive answer to frequency of testing. I hope this helps to answer your question. As things move forward, there will be additional communication with residents in the area from DNR and/or the responsible party.

The results show that you have no volatile organic compounds (VOCs) detected in your well water, which is great news! We will confirm these results with the sample we took and share those lab results with you once we receive them. The term "ND" under the result column means the analyte (aka VOC) was not detected. The "LOD" or level of detection is the smallest concentration the lab can detect the VOC at if it was detected. We were concerned with cis-1,2-dichloroethene (cis-1,2-DCE) and vinyl chloride. Cis-1,2-DCE was not detected and the LOD was 2.0, so that would be <2.0 ug/L. Vinyl chloride was not detected and the LOD was 0.20, so that would be <0.20 ug/L.
