Hi Rob,

Sorry for the delay getting back to you. We're still in the process of reviewing the ITA that you submitted this year, but it appears to be similar to the version submitted last year. There were eligibility concerns with last year's submittal (relating to whether the expansion of the water system met the criteria for addressing a public health concern from contaminated drinking water) and it was ultimately marked as Undetermined.

If we find that the ITA submitted this year meets the eligibility requirements, we would allow you to expand the scope of the project to include S 15<sup>th</sup> and 19<sup>th</sup> streets so long as it doesn't change the overall eligibility. So there's no need to amend or revise the submission this year (although if this project is submitted again next year I'd recommend specifying the additional streets).
