Tauren,

Just a quick follow-up.

As you know, the City is currently conducting a program of expanded potable well sampling for VOCs. The sampling protocol typically includes an AECOM field sampling team entering each house to conduct the sampling.

With the current situation associated with the Covid 19 virus, the City has determined that it's a good public health decision to pause sampling activities. So, as of this past Monday, March 16, 2020, we are not scheduling further sampling in an effort to protect the health of homeowners and staff.

The City is still accumulating a list of those homeowners who wish to have their water sampled. We will re-start the sampling activities once the public health professionals advise that public activities, such as our potable sampling, can recommence.
