Tauren,

On behalf of the City of Manitowoc, AECOM is requesting concurrence from the WDNR on a recent decision to pause 'on-site' VOC groundwater & surface water monitoring for this year. This request does not include our ongoing VOC potable well sampling efforts.

Typically, approximately 50 groundwater monitoring wells and 3 Silver Creek staff gauge locations are sampled for VOCs during an Oct/Nov sampling event. The wells are located on-site or on adjacent properties and include both water table wells and piezometers. The wells and Silver Creek have been monitored annually for a number of years, with the data showing little variation from year to year.

Our request is based on trying to effectively manage our limited resources while keeping the project moving forward. Essentially, with the budget impacts being created by the COVID-19 pandemic and the ramping-up of the project's emerging contaminant investigation, we feel it would be better use of our time and resources to focus on the emerging contaminant work than to conduct this year's VOC groundwater monitoring.

Please consider our request and let us know what the Department thinks.
