Hi Dave,

The DNR looked over the Five Year Potable Well Sampling Plan and has the following comments:

- Proceed with the May 2021 proposed sampling as defined in your workplan.
- Future sampling in the yellow zone: the other wells (22 wells) within the yellow zone that are not proposed to be sampled during the May 2021 sampling event should be sampled on a quicker timeframe since these wells are on the periphery of the blue zone, especially those wells in the yellow zone that have only been sampled once. DNR proposes that these remaining 22 wells be sampled in October 2021.
- Future sampling in the orange zone: Changes to a quicker sampling timeframe for the wells in the orange zone may be needed depending on the results in the blue and yellow zones.
- Potential future sampling of historic sampled wells: Based on future evaluation of the sampling results from the yellow and orange zones, additional sampling of historic sampled wells may be needed.
