The Commission directed the Division of Digital Access, Environmental and Consumer Affairs to draft an order consistent with its discussion.

### 3320-CW-115 - Application of the City of Manitowoc, as a Water Public Utility, for Authority to Construct a Water Main Extension Project Outside the City of Manitowoc's Corporate Limits, Manitowoc County, Wisconsin

The Commission authorized, with conditions, Manitowoc Public Utilities' (MPU) request to extend service in the Towns of Newton and Manitowoc and to construct a water main greater than 8 inches in diameter and longer than three miles, and made the following additional determinations:

- 1. MPU shall work with landowners adjacent to the pipeline to mitigate impacts to trees adjacent to the workspace to the extent practicable.
- 2. In lieu of providing information about laydown yards, MPU shall utilize existing parking lots or agricultural fields.
- 3. MPU shall submit executed Intergovernmental Agreements (IGAs) (but not non-resident service agreements) to the Commission prior to initiating service in the affected area and shall not begin construction of the project until it has executed IGAs with both the Town of Newton and the Town of Manitowoc.
- 4. MPU shall work with Commission staff on the development of reporting requirements and report to the Commission in a format and frequency to be determined by Commission staff and MPU. The reports shall provide information on the status of the remediation, including information relating to the contaminant plume migration, the contaminants sampled, the frequency and results of groundwater and private well sampling, the number of customers connected to the extended service, and any customer complaints received regarding eligibility for or connection to the extended service.

- 5. MPU shall work with Commission staff to develop a revised tariff defining the terms of service in the extended service area to be served by the main extension authorized in this proceeding. The revisions shall identify the definition of groundwater contamination and contaminants of concern for which the tariff applies, and identify the specific standards applicable for qualification for service under the tariff. MPU shall submit the revised tariff, along with additional information that is in support of the terms of the tariff and that relates to the extent of the contamination and the expected customers that are impacted for the duration of time that the tariff is in effect, and any other relevant information, for the Commission's consideration and approval.
- 6. MPU's request for an accounting waiver is granted for this specific project, allowing MPU to record assets associated with the project in Account 101.2 (Utility Plant in Service Contributed Plant).

The Commission directed the Division of Water Utility Regulation and Analysis to draft an order consistent with its discussion.

The Commission adjourned the meeting at 11:07 a.m.

Manitowoc Public Utilities (MPU) filed an application with the Public Service Commission of Wisconsin (Commission) on May 18, 2020, seeking authority to construct water main extension facilities in the City of Manitowoc, Town of Manitowoc, and Town of Newton, all in Manitowoc County, Wisconsin. The Commission is a state agency that regulates utilities and investigates proposed water supply projects of a given size or cost. The Commission is sending this letter to property owners near the proposed water main extension route. It is also being sent to public officials who may wish to place this notification in a location where it can be viewed by the public.

This is a Type II action under the Wisconsin Environmental Policy Act, Wis. Admin. Code § PSC 4.10(2). Type II actions require the preparation of an environmental assessment (EA) to determine whether an environmental impact statement (EIS) is necessary under Wis. Stat. § 1.11. A notification of the Commission's intent to prepare an EA, including a solicitation for comments on the environmental aspects of this project, was mailed to landowners, local and regional media, affected municipal entities, the regional planning commission, and area legislators along the proposed route on July 20, 2020. An EA was prepared by Commission staff after receiving public comments and project information from MPU.

The preliminary determination indicates that no significant impacts on the human or natural environment are likely to occur as a result of the construction and operation of this project. Therefore, preparation of an EIS is not required. Comments regarding this determination can be directed to the contact person listed at the end of this letter. The remainder of this letter describes the primary impacts of the project and summarizes the conclusions of the EA. To obtain a copy of the EA, please request a copy from the contact person listed at the end of this letter.

### **Proposed Project**

The project would consist of the installation of new water main to provide MPU-drinking water to multiple non-City properties that currently obtain their drinking water from impacted private potable groundwater wells. This would include the construction for a new water main from the existing MPU system as well as lateral service connections and house connections. The project would be completed in four phases, with a total estimated pipeline distance of 20,771 feet. The

water main would be constructed almost entirely within road ROW. MPU states one area of an easement acquisition to allow the pipeline to cross an agricultural field would be negotiated with a private landowner.

The four phases of extensions would extend water main along the following roads:

- Extension #1 –Starting from the existing water main on County Highway (CTH) CR, south to Thunder Ridge Road. It would proceed east and north along Thunder Ridge Road to Blackhawk Court and then east along Blackhawk Court.
- Extension #2 Starting from Viebahn Street, it would proceed south along South 26th Street to Jenny Road. It would then proceed east along Nelsen Lane, as well as east along Birch Road, Elm Road, and Jenny Road. Also, north along Cimarron Court.
- Extension #3 South along South 19th Street, from Viebahn Street to Lissa Lane. West to Jenny Road and east to South 15th Street.
- Extension #4 –South along South 15th Street, from Viebahn Street to Lissa Lane. West along Loan Oak Lane.

### **Project Need**

MPU states there are approximately 110 wells located within the proposed water main expansion area, 44 percent of which, at the date of the application, are impacted with chronic contamination by volatile organic compounds. MPU states the wells in the area not yet impacted are considered to be at imminent risk of contamination. MPU can provide potable water via bottles or replacement wells; however, MPU proposes the current project as a long term solution to the problem of well contamination in the project area.

Currently, the City of Manitowoc and MPU reports they do not have the authority to require private homeowners with contaminated potable wells to connect to the new water main. MPU is currently taking a voluntary approach to encourage homeowner participation. The DNR has stated that the City's obligation is to provide a source of drinking water, and the property owner has the final decision as to whether or not to connect. That situation may change in the future. As part of the project, private wells would be abandoned after water main hookup, with the City likely covering the costs of well abandonment as well as water pipeline construction.

### **Potential Natural Resource and Social Impacts**

MPU would acquire all necessary easements and permits prior to the start of construction. Site preparation activities would include clearing vegetation and grading soil, as needed, to provide a level work area for pipe laying and transport. As construction would occur adjacent to roads, the road shoulder would likely be closed to provide more room for construction crews. Road lanes may also need to be closed to allow for construction to safely proceed. The installation of the water supply pipeline would predominately be done through open trenching, where any hard surface or paving and soils are excavated and then replaced after the pipe is installed.

Construction equipment to be used includes dozers, graders, excavators, trenchers, backhoes, dump trucks, and various other trucks or machinery. Trench sizes can vary depending on construction areas, available space, any existing infrastructure, or environmental requirements. MPU states that the typical trench dimensions would be eight feet wide, and minimum six feet of burial depth for the pipeline. Three waterways, County Highway CR, and some other local roads would be directionally bored (trenchless construction) to reduce impacts of construction. The disturbance zone would be within the public road ROW, with the exception of approximately 1,200 feet off of Jenny Road extended across private property, which would require a permanent easement.

The proposed project would create increased noise, vibrations, and air pollution in the areas of construction. Individuals in the immediate vicinity of construction activities would experience these impacts from construction activities and may find them annoying or disruptive. Where the route would cross roads or driveways, there would be impacts to landowners or those driving in the area. Some roads and driveways would likely experience closures for some duration, often not more than 24 hours. Localized dust and diesel fumes would be expected as a result of construction activity and vehicle traffic. The potential for erosion and runoff would be expected in areas of excavation or materials storage. The use of BMPs and appropriate erosion control measures should avoid or minimize this risk.

Questions from the public included what changes would happen due to water service connection both for water supply and waste disposal. At this time, no extension of sewer service is planned. Residents would become customers of MPU and pay for water service; although, details of these arrangements have not been finalized. Costs of installing water pipeline and restoration of the construction disturbance zone would likely be covered by the City of Manitowoc, not the residents of the area.

### **Conclusion**

The analysis in the EA finds that no significant or long-term environmental effects would be expected to result from the proposed project along the potential routes as described with stated construction methods and mitigation plans. The primary community impacts include localized noise, vibrations, dust, and diesel fumes. In addition, some lane closures and traffic congestion would likely occur along the project route as construction activities are in a given area. All of these impacts would be short-term. No environmental impacts that would warrant the preparation of an EIS are expected. Thus, preparation of an EIS as described in Wis. Stat. § 1.11 is not required for this project.

DNR does not need to look at the Public Service Commission questions anymore. I got an update that the Public Service Commission doesn't have any more questions for the environmental aspects of the project and provided a letter to the City on 2/19/2021 stating that. I asked that the City provide the letter so I have a copy of it. They only have non-environmental questions now, which DNR would not get involved with.

The only question now that DNR needs to provide is in relation to the screenshot below. The City has asked for an explanation on what the statute or code reference is on if the property owner refuses to connect the City can't force impacted properties to connect to the water main. Roxanne indicated to me that you have likely already answered this for some other sites such as the JCI site.

### Request No: PSCW-MBW-25:

At the present time, Commission staff understands connection to the public water mains would be voluntary. Will the service agreements with the Towns of Newton and Manitowoc provide provisions that would require affected properties to connect to the proposed water mains?

### Response:

Per the WDNR's representation to the City of Manitowoc on the City's obligations under relevant Wisconsin law, the City of Manitowoc may not mandate affected properties to connect to the proposed water mains. Per the WDNR, the City of Manitowoc must show proof to the WDNR that the property owner rejected the offer of hook up and then the WDNR will reach out to the property owner to confirm rejection.

### **Request No: PSCW-MBW-20**

The proposed water main extensions are intended to service properties in the Town of Newton and the Town of Manitowoc that currently have private wells that are contaminated with volatile organic compounds (VOCs). In its data request response to PSCW-MBW-3, the Utility acknowledged its current tariff provisions do not allow the Utility to extend water mains outside the City of Manitowoc's (City) corporate limits. (PSC REF#: 395112) How does the Utility propose to address the present limitation on water main extensions outside the City's corporate limits? Is the Utility specifically seeking authority from the Commission to extend service outside the corporate limits as part of its construction application?

Please verify the current estimated project cost. Provide a breakdown of those costs by construction within public rights-of-way and construction on private property. Will grants or loans through the Safe Drinking Water Loan (SDWL) program allow these funds to be expended on private property? Describe. If SDWL funds cannot be used to pay for privately owned service lines and abandonment of private wells, how does the Utility propose to fund these construction costs?

### **Response:**

MPU intends to submit a request for one or more tariff modifications to address the current language in its tariffs that limits such water main extensions to within the City of Manitowoc boundary. MPU intends to make that filing in the near future, and anticipates seeking Commission resolution of that tariff modification(s) on the same or similar schedule as the decision on the current request for a certificate of authority for the water infrastructure. Additionally, the City of Manitowoc intends to enter intergovernmental agreements with the Town of Newton and the Town of Manitowoc, pursuant to Wis. Stat. § 66.0813(3)(b), to provided limited water service to those towns, through MPU, once the PSCW has approved this project. MPU currently provides service to certain customers in the Town of Manitowoc and the Town of Newton, as further described in MPU's response to PSCW-MBW-5. As such, it does not believe it needs a certificate of authority to serve those "municipalities." *See* Wis. Admin. Code PSC § 184.03(2) (requiring a certificate of authority prior to "[c]onstructing facilities or initiating service in a municipality not currently served by the utility."). However, MPU's application in this proceeding, as well as its data request responses to date, provide substantial

evidence to support a request to extend additional service to the two towns. To the extent the Commission disagrees with MPU's conclusion that a CA is not needed for the express purpose of providing such additional service, it requests that the Commission treat the application as seeking such approval.

The current estimated Project cost is \$3,137,406, for construction activities that require Commission approval. The original filing provided a figure of \$3,429,900 (Application at Section E). That figure included \$602,165 for costs that are not jurisdictional to the PSCW (lateral to the home, plumbing in the home, well abandonment). The City of Manitowoc's SDWL application used a figure of \$3,739,571, which included the above-mentioned \$3,429,900 plus additional costs for engineering, inspection, and contingency. The SDWL grant will not allow funds to be used to tie in properties to the water main. The City of Manitowoc will be funding these costs. Well abandonment costs are eligible to be reimbursed through the SDWL monies.

Non-participating MPU customers will not fund any costs of the Project.

### **Request No: PSCW-MBW-21:**

In addition to funds from the City, does the Utility intend to assess properties that will be served by the water main or use other connection charges? If the Utility will use more than one funding source, please provide a breakdown of project costs by funding source. Does the Utility intend to record the new infrastructure as Utility Financed Plant or Contributed Plant? If the Utility intends to use both account types, please provide a breakdown by plant account, keeping in mind that the Uniform System of Accounts (USOA) requires that plant funded by the Utility or City by [sic] classified as Utility Financed Plant. Under the USOA, plan [sic] funded by assessments or other similar charges to the property owners is required to be classified as Contributed Plant, even if the property owner is not required to pay the assessment until a future year.

### **Response:**

MPU does not intend to assess properties that will be served by the water main, or otherwise assess connection charges. The water main will serve only customers with contaminated properties, as determined by the City of Manitowoc, and only the subset of those customers who want to be connected to the water main. The City of Manitowoc will pay for all costs associated with connecting such customers to the MPU system.

The entire cost of the Project is being paid for by the City of Manitowoc, which will receive a portion of the funding from a SDWL loan from the Wisconsin Department of Natural Resources. MPU would like to record this investment as Contributed Plant for both the portion paid for through forgivable SDWL money as well as the non-forgivable component of the SDWL funding. This will ensure current ratepayers are not negatively impacted by the cost of the Project and represents a change from MPU's initial filing. As noted in the response to PSCW-MBW-22, MPU is seeking a waiver of the traditional accounting treatment for these assets.

### **Request No: PSCW-MBW-22:**

Commission staff understands that the Utility desires to minimize construction and other future costs for the project from being allocated to current and future customers of the Utility in future rate cases. Is the Utility requesting that the Commission consider non-standard accounting treatment for the project costs that are required to be classified as Utility Financed Plant under the USOA or for operating costs related to serving customers outside the City limits? If so, what is the Utility's proposal?

### **Response:**

MPU does want to minimize costs of this extension to non-participating customers of the utility, as the extension is being done to address a specific and unique need of customers residing outside of the City of Manitowoc. While MPU and the City of Manitowoc recognize and are acting on the impact of past actions to these new customers' existing water supply, that action should not, to the extent possible, result in additional costs to other MPU customers.

In order to ensure a *de minimis* impact of the current application to existing MPU customers, MPU seeks non-standard accounting treatment for certain Project costs. The total cost of the Project would be booked to 101.2 — Contributed Plant. MPU also seeks a waiver from allocating O&M costs of the Project to all customers and seeks to isolate those costs to the customers connecting to the Project. MPU's accounting system can segregate costs through 'projects' (i.e. distinct costs). Types of costs would be:

- Labor for operating valves, flushing hydrants, responding to main breaks, etc.
- Treatment costs (chemicals/power/etc.) allocated based on sales volumes.
- Existing infrastructure to serve including treatment plant and mains to get to the Project site allocated based on sales volumes.
- System wide studies allocated based on volume sales.
- Any other unforeseen O&M costs not specifically identified.

The City will be responsible for the future replacement of the water mains upon asset end of life should the asset not become located within City of Manitowoc limits prior to reaching end of life.

### **Response:**

In addition to the modification to the main extension tariff that MPU intends to file, it also will file for approval of a new tariff to cover service to customers who reside outside of the City of Manitowoc limits and receive service on either the Viebahn infrastructure or the infrastructure that is the subject of this proceeding. That tariff that will include the following:

- A pro rata share of the O&M costs for other MPU infrastructure that will serve them.
- A pro rata share of the capital costs for other MPU infrastructure that will serve them.
- The cost to pump and treat the water provided.
- Allocated share of system wide studies and any other unforeseen costs not specifically identified.

O&M costs attributable to the specific assets servicing customers not residing in the City of Manitowoc and receiving service from this Project or the Viebahn project will be paid for by the City of Manitowoc going forward. The City of Manitowoc does not intend to otherwise subsidize the new customers' water bills. Each new customer is responsible for their water bills under the new tariff to be filed by MPU.

In response to PSCW-MBW-6, the Utility stated that 4,891 feet of water main was installed at a cost of \$311,642 on Viebahn Street and County Road CR in 2015 to serve residences with contaminated wells. (PSC REF#: 395112.) The Utility stated that this water main extension that is a mix of City and non-City property owners was fully funded by the City. The Utility further stated that, as additional properties connect, the City is reimbursed through assessment charges to property owners.

- a. The Utility reported an addition of \$368,263 for Viebahn Street water main in Account 200 (Capital Paid In by Municipality) in the 2016 PSC Annual Report. Please explain why this amount is higher than the \$311,642 cost of the water main extension.
- b. Provide a list of properties that have connected to the water main so far and the amount assessed to each property owner and reimbursed to the City.
- c. Does the Utility expect that property owners both those within and outside the City will eventually reimburse the entire cost of the water main extension to the City? Is this amount \$311,642, \$368,263, or some other amount?
- d. How has the Utility reported the reimbursement by property owners in the PSC Annual Reports? Please provide a copy of all relevant entries.
- e. Were property owners responsible for the cost to abandon private wells, or did the City reimburse property owners for this cost?

### **Response:**

- a. MPU used the water main construction cost of \$311,642 in its response to PSCW-MBW-6. The \$368,263 in Account 200 in the 2016 PSC Annual Report is the full book value, and includes construction, design, engineering, and other associated costs. This was all funded by the City.
- b. There have been nine (9) residential water laterals and connections to the Viebahn Street extension, at the following locations:

2717 CTH CR/4141 Viebahn 2734 CTH CR 2916 CTH CR 3617/3621 Viebahn\* 3701 Viebahn 3815 Viebahn 4025 Viebahn\* 4101 Viebahn\* 2917 CTH CR

These nine properties were part of the original planned connections to the Viebahn Street extension and were not assessed by the City. In 2017, Forest Creek Apartments petitioned to connect to the water main, and were allowed to connect. They were assessed \$18,305 and that money was provided to the City. The three asterisked properties are inside the City of Manitowoc.

- c. MPU does not anticipate that enough customers will connect to the Viebahn Street extension to reimburse the full amount expended by the City.
- d. The Utility recorded the above assessment as follows:
  - 1. Debit Accounts Receivable \$18,304.92 / Credit 421-Contributions \$18,304.92 (bill to apartment complex).
  - 2. Debit 421-Contributions \$18,304.92 / Credit Accounts Payable \$18,304.92 (remittance of funds to City).
- e. The City of Manitowoc contracted and paid for well abandonment.

Was the Viebahn Street and County Road CR water main extension reported as plant additions in the 2015 or 2016 PSC Annual Report? Please identify all project costs added to plant by PSC account number and specify if the costs were added to Utility Financed Plant or Contributed Plant.

### **Response:**

The Viebahn Street / County Road CR water main extension was reported as plant additions in 2016. Although the water main was installed in 2015, street reconstruction and timing of the SDWLP application for City extend the project closeout into 2016. Project costs added in 2016 were as follows:

Account 325 (Electric Pumping Equipment	\$2,393.40
Account 343 (Distribution Mains)	\$282,048.68
Account 348 (Hydrants)	\$83,821.21
Total Costs	\$368,263.29

This project was erroneously recorded to contributed plant as staff assumed any plant not paid for by the utility was considered contributed. Consistent with the request to treat this CA project as Contributed plant, MPU requests retroactive approval of recording this Viebahn Street project to Contributed Plant as well. The six (6) properties currently served by the Viebahn Street project that are outside of the City limits would be transferred to the proposed new tariff. If in the future the City were to annex properties served by this Project or the Viebahn Street project into the City, MPU would request PSCW approval to transfer the net book value to Utility Financed and then transfer the customers to its standard water rate tariff for retail customers. If annexed, the City's responsibility to replace this water main at end of life would be eliminated and become part of the utility's rate base which would earn a rate of return and depreciation expense recovery to fund the future main replacement.

The City has received numerous calls regarding the letter you received from the Public Service Commission (PSC) about the potential water main construction. This letter is to update you on the activities the City has undertaken and answer concerns you may have.

As part of an ongoing environmental groundwater investigation associated with the Former Town of Newton Gravel Pit, the City of Manitowoc has expanded potable well testing for volatile organic compounds (VOCs) into the Town of Manitowoc.

During the sampling that took place over the winter and this spring several properties on S. 15<sup>th</sup> Street and S. 19<sup>th</sup> Street showed the presence of VOCs above Enforcement Standards. Affected property owners were notified by the City and bottled water is being supplied until a permanent clean water source is determined. Additional testing in the area is ongoing.

The City is looking at several options to supply a permanent clean water source to affected properties including the feasibility of running municipal water. In order to install the water main, a number of steps would need to be taken, including:

- Design of the water main
- PSC approval of the water main construction
- Obtaining financing for construction of the water main
- Reaching agreements with the townships to install water mains
- Wisconsin Department of Natural Resources (WDNR) approval of the water main as a remedial solution
- Manitowoc Public Utilities (MPU) Commission approval to construct water main
- Manitowoc Common Council approval to construct the first phase of the water main
- Public bidding of the water main in accordance with Wisconsin Law

Currently, MPU has applied for PSC approval for the water main and the City has applied for a Safe Drinking Water Loan from the WDNR to help finance the main. In order for PSC approval to be granted,

the PSC needs to take a number of steps, including notifying prospective properties that may be served by the main about the proposal from MPU.

### **Frequently Asked Questions**

- Who will pay for the water main? The City of Manitowoc will be paying for the water main, hook up at affected properties and well abandonment at affected properties.
- Will I be able to hook up to water main? If your property has had a detect, you will be able to hook up to the water main.
- The letter said you would be starting construction in June of 2020. What is the status? If water main is the approved option construction would not start until summer 2021.
- The letter states that my well is in imminent danger of being contaminated. What does that mean and when will you be testing wells not affected again? Due to the nature of fractured bedrock the City cannot predict where future impacts may be. The City is developing a sampling plan with the WDNR that is continuously evolving as more information becomes available.
- Will you be running sanitary along with water main? No
- Will you be annexing my property? The City is not considering, nor can they legally request, properties in the Town be annexed into the City.






