Hi Andrea - I write to provide Newell Operating Company's ("NOC") bi-monthly status update on the Former Newton Gravel Pit site. Since NOC's January 31, 2022 update, the City and NOC have reached an agreement for NOC's payment of a portion of the City's 2020 Gravel Pit-related costs. Counsel for NOC and for the City had a call on March 3, during which counsel for NOC requested information on when the City would be able to provide its 2021 costs so that the parties can begin discussions about reimbursement of a portion of those costs. Counsel for the City agreed to provide an update on that timing this week.
