Andrea,

With June 1st approaching, I write to provide an update on developing a schedule for cost recovery for 2021 and beyond.

As we reported through Katie's email on February 2nd, the City reported during the parties' January 28 phone call that it was gathering information regarding those costs and would forward them to NOC for review. NOC further committed to working with the City to

establish a set schedule for the City to provide NOC with its cost information for the previous year, together with a demand for payment of a portion of those costs.

As I reported in my May 13th email, below, the City provided NOC a spreadsheet outlining its 2021 Gravel Pit-related costs on May 2nd and informed us that it would assemble the backup for the identified costs. Since May 13th, I have corresponded with Ned Witte, counsel for the City, regarding both the 2021 backup and the DNR's request that we establish a schedule for cost recovery for 2021 and beyond. I understand that the City is still in the process of assembling documentation to support its summary of 2021 costs. NOC will promptly review that documentation upon receipt.

In light of the fact that NOC does not know when it will receive the cost documentation for 2021—or for future years—we do not anticipate having an agreed upon schedule by June 1st. NOC remains committed to working with the City to establish a schedule, as we expressed in our February 2nd email.
