Dear Mr. Pettinelli:

Thank you for taking the time yesterday to inspect the 3M Downtown parking lot site with me. Historically the parking lot had been used by a motor parts company and a release of trichloroethene (TCE) occurred. An investigation and cleanup of the TCE contamination took place and the site was closed on April 24, 2008 with continuing obligations. The continuing obligations included the maintenance of the asphalt cap.

As I mentioned when I set up the site inspection, I needed to ensure that 3M was complying with the continuing obligations of cap maintenance and annual inspections. You informed me on Tuesday that your company had not completed any of the annual inspection forms since the site has been closed, however, you would start that process this year. You also stated that the forms would be completed on an annual basis from now on.

During our walk around the parking lot I pointed out several large cracks in the truck parking area asphalt that needed repair. The rail area of the cap appeared to be in excellent condition.

We also discussed the inspection form during my visit. Rebecca Robbennolt (ARCADIS), your consultant provided you with a generic inspection form for your use and stated she could customize it for your site if needed.

Based on my inspection, two items need to be completed to meet the continuing obligations. Cracks in the truck area need to be repaired and annual inspection forms must be filled out. In addition I requested that you update the figure in your maintenance plan to include the additional tracks that were added to the cap. Also if there are maintenance requirements that are required by another agency for the track area, please reference those requirements in the documentation that you submit to me.

Within 60 days of the date of this letter, please provide me with this year's inspection report and the parking lot repair documentation. After I receive these documents I will enter the correct action code in our BRRTS database stating that you are back in compliance with your continuing obligations.
