This letter is to notify you that the Department of Natural Resources (DNR) received analytical test results collected from the well at 210 S. Washington St., Unity, Clark County, and inform you of the contaminants found and provide additional information.

Tetrachloroethene (PCE) was detected at 5.2 parts per billion (ppb) which exceeds the state groundwater enforcement standard of 5 parts per billion. Trichloroethylene was detected at 0.36 ppb which is below the state groundwater enforcement standard of 5 ppb. Cis-1,2-Dichloroethene was also detected at 0.57 ppb which is below the state groundwater enforcement standard of 70 ppb.

This letter is to notify you that the Department of Natural Resources (DNR) received analytical test results collected from the well at 210 West Clark Street, Unity, Clark County, and inform you of the contaminants found and provide additional information. The well was sampled for Volatile Organic Compounds (VOCs) by DNR on October 22, 2018 as part of the monitoring required for the chlorinated solvent contamination issue in the Village of Unity.

In the pre-treatment water sample tetrachloroethene and trichloroethene were detected at concentrations of 220 micrograms per liter ( $\mu$ g/l) and 21  $\mu$ g/l, respectively, which exceed their groundwater quality standard of 5.0  $\mu$ g/l for each compound. State groundwater standards are established to The VOC compound cis-1,2-dichloroethene was also detected in your water sample, however this compound was detected below state groundwater standards.

No VOCs were detected in either of the post-treatment samples collected from this well. Based on the water sample results the carbon treatment system installed at this location is effective in removing the VOC-related contaminants from your water.
