- 1. I am a Remediation and Redevelopment Program Supervisor, employed by the Wisconsin Department of Natural Resources (hereinafter "the Department") at its West Central Regional office and I have personal knowledge of the facts herein set forth and believe the same to be true.
- 2. The Department has determined that chlorinated volatile organic compounds discharged to Garry's 1 Hour Cleaners ("the Property"), which is located at 912 South Central Avenue, in the City of Marshfield, County of Wood, and which has the above legal description, has contaminated soil, groundwater, and soil vapor in the vicinity.
- 3. The Department has determined that soil, groundwater, and soil vapor contamination has been identified on the Property which has not been adequately defined or remediated.
- 4. On June 12, 2018, the Department sent a letter to Garry Eckes, of Garry's 1 Hour Cleaners, advising him of the statutory requirement to restore the environment at that location. An inadequate response to that letter was received by the Department on September 21, 2018.
- 5. Per Wis. Admin. Code § NR 728.11(2)(a), on February 20, 2020, the Department sent a letter, by certified mail, to Garry Eckes advising that a notice of contamination would be recorded if he did not commence with the required actions to address the environmental contamination at the Property. The letter requested a written response from Garry Eckes by March 21, 2020. An inadequate response to that letter was received by the Department on March 12, 2020.

Additionally, per Wis. Admin. Code § NR 728.11(2)(c), the 15-day waiting period since that deadline has passed without an acceptable response.

Because the Department believes that chlorinated volatile organic compounds currently found in the soil and groundwater on the Property at the above legal description will continue to discharge into the environment, subsequent purchasers of the Property may be held responsible for investigation and cleanup costs under Wis.
