ACCESS PERMISSION AGREEMENT

I, **Garry Eckes**, hereby give permission to the Wisconsin Department of Natural Resources (DNR) and its employees, duly authorized representatives, agents and contractors, to enter upon and have access at reasonable times to the business(es) located at **912 South Central Avenue, Marshfield, Wisconsin** and that is owned by **Garry Eckes**.

The property is located in the SW $\frac{1}{4}$ of SW $\frac{1}{4}$ of Sec. 8, T25N, R03E, Wood County, Wisconsin (**Parcel ID No. 3303180B**). The access permission is for the following purposes: that the DNR may screen the business(es) for vapor migration from chlorinated volatile organic compounds (CVOCs) located in soil, groundwater and air, associated with the former **Garry's 1 Hour Cleaner's site (BRRTS #02-72-000296)** located at your property. This permission allows the DNR or its authorized representative to:

- (1) Install and maintain sub-slab vapor probe(s) into the foundation of the home or business.
- (2) Collect vapor samples from the sub-slab probes at different times of the year for up to two years.
- (3) Collect, if necessary, a 24-hour indoor air sample on each level of the business.
- (4) Collect, if necessary, soil-gas sample(s) within the vicinity of the business.
- (5) Collect, if necessary, vapor samples from floor drains, sewer cleanout locations, sumps, manholes, and bathrooms or locations served by a sanitary sewer.
- (6) Abandon the vapor probe(s) when no longer needed, if requested.

The permission that is granted shall remain in effect until **December 31, 2022** when the vapor screening work is expected to be complete. If an extension is necessary to complete the work, DNR will inform you in writing.

The property owner agrees not to damage or interfere with the use of any sub-slab probe installed as permitted herein.
