Hi Garry,

Thank you for calling me back. The results of the vapor sampling event that occurred on February 4th at the Garry's 1 Hour Cleaner's site has been received. I will be sending you a letter with those results in the mail. Two vapor samples within the location of the former dry cleaner business had results that are over the department's vapor risk screening level. Under [NR 70811\(1\)\(b\)](#) a vapor mitigation system will need to be installed at the building, ideally within two weeks. If you foresee issues with getting this installed within that timeframe, please let me know so that we can coordinate interim actions until that can be installed.
