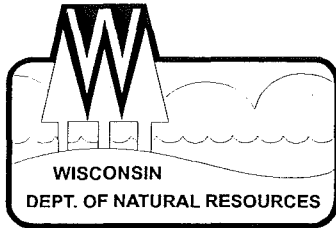

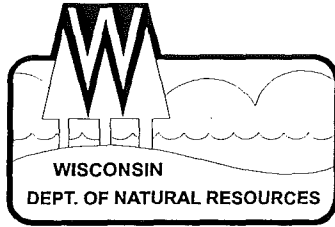

Dear Mr. DeKeyser:

The above-named site was reviewed by the Northeast Region Closeout Committee for a determination as to whether or not the case qualified for closeout under ch. NR 726, Wis. Adm. Code. This panel reviews environmental remediation cases for compliance with state laws, standards, and guidelines to maintain consistency in the closeout of cases. The Closeout Committee has approved the closure of this case. Based on the investigative and remedial documentation provided to the Department, it appears that the contamination at the above-named site has been remediated in compliance with the requirement of chs. NR 700 to NR 724, Wis. Adm. Code. Therefore, the Department considers the case closed, having determined that no further action is necessary at the site at this time. However, this case may be reopened pursuant to s. NR 726.09, Wis. Adm. Code, if additional information regarding site conditions indicate that contamination on or from the site poses a threat to public health, safety, welfare or the environment.

All groundwater monitoring wells, sumps, and soil vapor extraction wells at this site will need to be properly abandoned with the proper documentation of such abandonment filed with the Department. This case will not be listed as closed on the Department's case tracking system until **after our receipt of the monitoring well abandonment forms (Form 3300-05B) for all the monitoring points.** Thank you for you and your consultant's cooperation and cleanup efforts during this process. 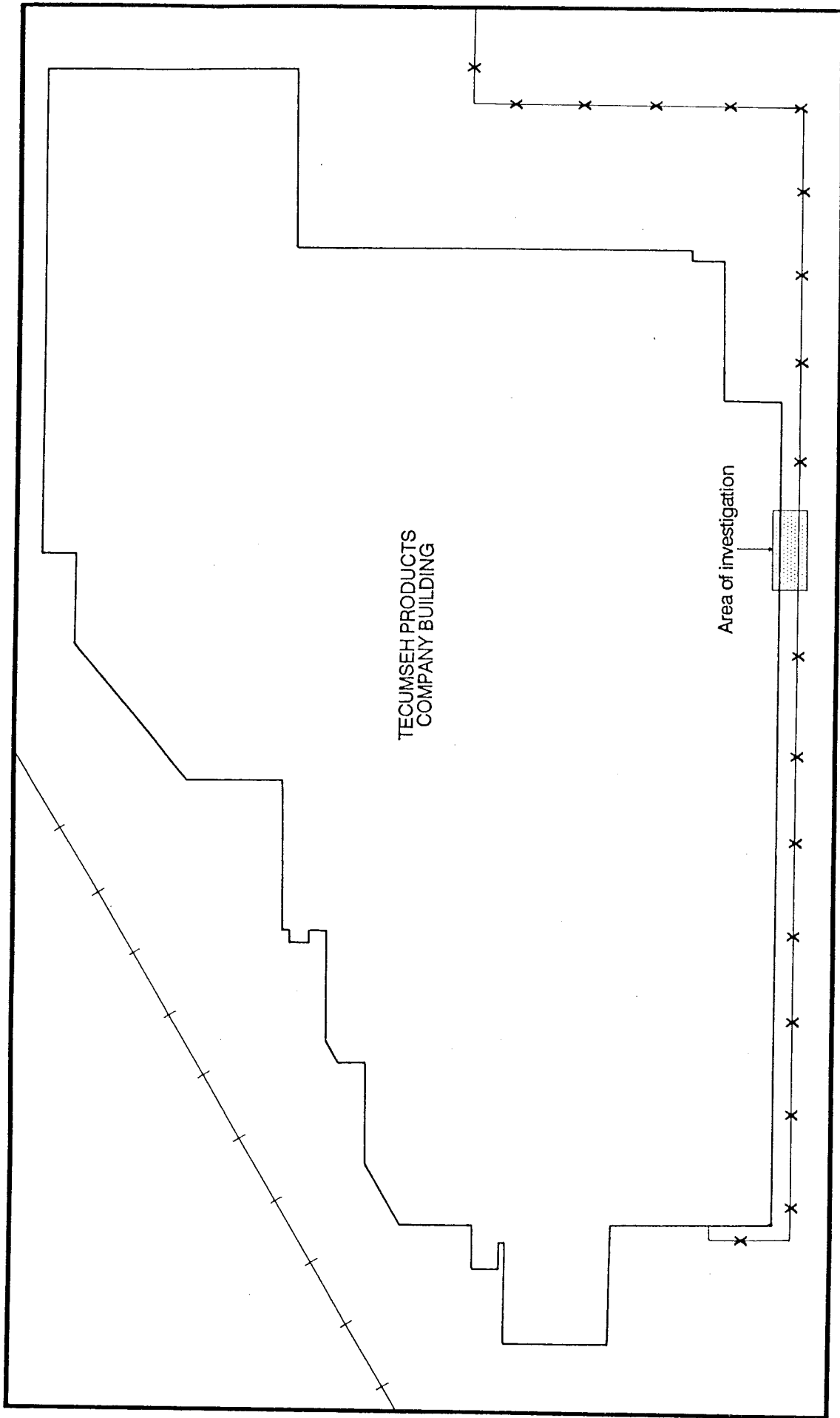

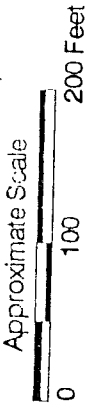
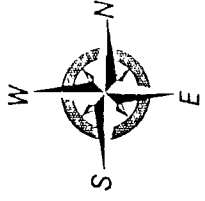


Figure 1

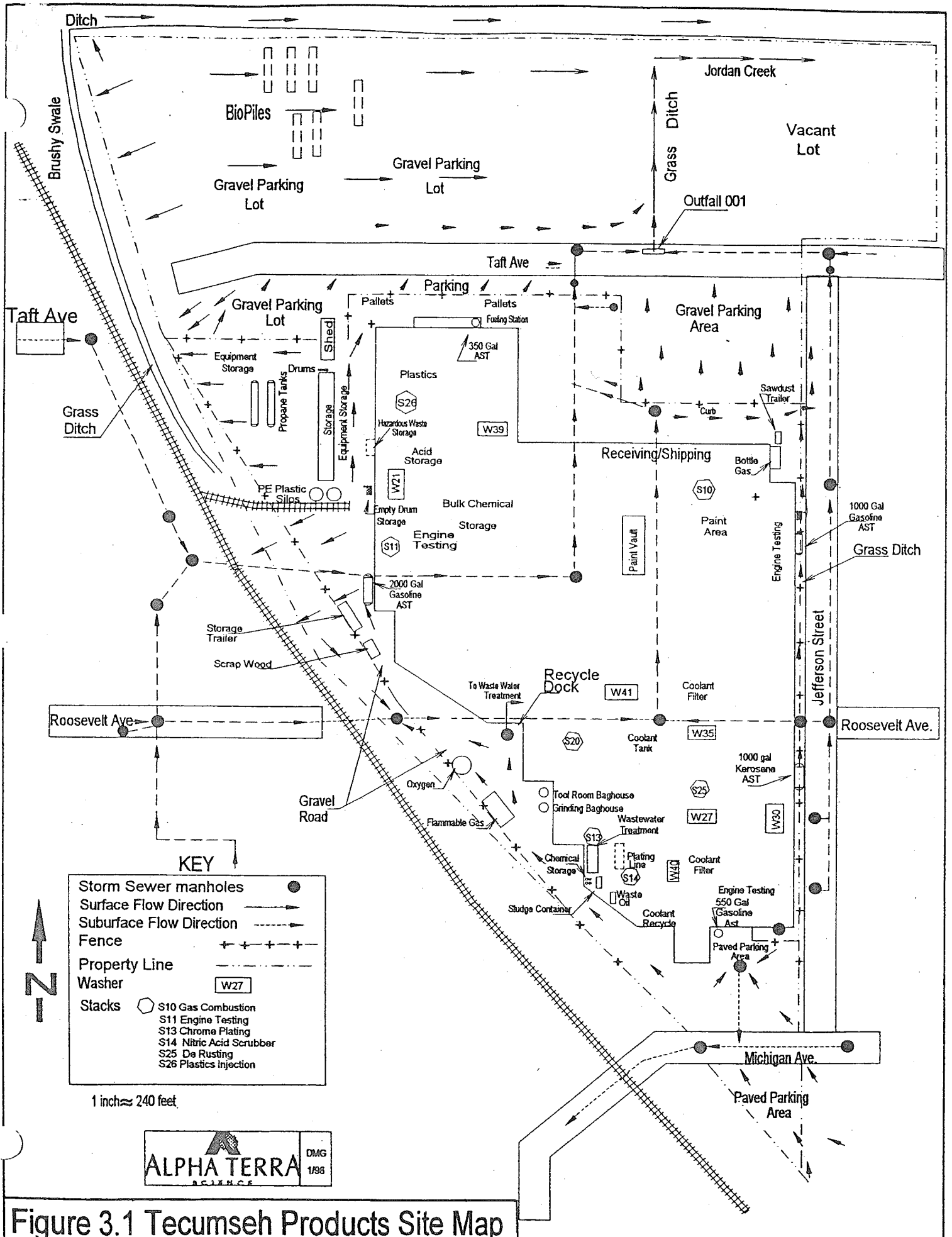


Figure 3.1 Tecumseh Products Site Map
