The purpose of this letter is to advise you that the OS Group is the new DNR contractor for environmental work at the Onalaska Landfill. Steve Osesek, representative of the OS Group, reported to DNR that he visited with you during a routine groundwater monitoring event in late April and offered sampling of your well for analysis of several health-related substances. He stated that you were concerned about the change in contractors from Braun Intertec to the OS Group and wanted confirmation from DNR of that change. The DNR contract with Braun Intertec expired in 2017 and, under state procurement rules, the OS Group was selected for the next phase of work at the landfill.

If you agree to sampling of your well, please sign and return the enclosed Access Permission Form in the stamped, self-addressed envelope provided.

After receipt of your access permission, your well will continue to be sampled on a regular basis, and we will continue to notify you of the results. Samples will be analyzed for the presence of volatile organic compounds (VOCs). VOCs are compounds found in such things as gasoline, diesel, oil and other industrial cleaners and solvents. Your water will also be tested for some inorganic compounds, including but not limited to barium, manganese, and iron.
