Regarding your current Groundwater Monitoring Report for the Onalaska Landfill, I discussed the necessity of a NR 712 Professional Engineer (P.E.) certification with our program coordinator. In this case, your contract is a "goods-and-services" contract which specifically excludes any interpretation by the current consultant and requires only groundwater sampling and reporting. In addition, it is my understanding that there is precedent for not requiring P.E. certification at some sites where all engineered remedial activities were previously implemented by others and groundwater sampling and reporting are the only remaining activities. Therefore, certification by a "hydrogeologist" as defined by NR 712 will be sufficient in this instance. Thanks.
