Hi All,

My conversation last fall with Mae Willkom the superfund site manager for WDNR suggested that this wouldn't be a concern for WDNR to put a turtle nesting box on the west side of the fence (river-side) at the Onalaska Superfund site. I just spoke to Rolly and based on the understanding that the project wouldn't disturb the superfund cap (with WDNR permission), etc... the city of Onalaska is ok with this project proceeding on their property. I am still willing to help guide the installation of this, and give advice this spring, with the prior understanding that Brice Prarie would purchase the materials and help with installation and follow-up monitoring/keeping vegetation in check.

Including Mae in the discussions again, to double-check that this is officially fine to proceed with. After we hear back from Mae (for final approval), we can begin discussing a date(s) to get this underway.
