The Wisconsin Department of Natural Resources' (DNR) received the January 31, 2018 *Ready for Reuse Grant RRG-034.1 and RRG-047 Funding Approval Request, KEP Groundwater Remediation - 2018* (Funding Approval Request) that was prepared by AECOM Technical Services, Inc. (AECOM) for the former Kenosha Engine Plant (KEP) site. The Funding Approval Request is for the DNR to approve use of the Ready for Reuse Grants RRG-034.1 and RRG-047 to conduct groundwater remediation at the former KEP. Specific tasks include: i) preparing a groundwater remediation design report; ii) preparing and publishing a 30-day public notice for the remediation; iii) preparing injection permit applications; iv) preparing plans and specifications for the groundwater remediation, including a pre-bid meeting; v) completing groundwater remediation and overseeing remediation contractor activities; and vi) preparing a groundwater remediation documentation report.

After reviewing the Funding Approval Request, the DNR met with AECOM to discuss the results of the groundwater pilot testing at KEP. Subsequently, the DNR received and reviewed the March 7, 2018 *In-Situ Chemical Oxidation Pilot Test Documentation Report* that was prepared by AECOM. Following the review of all the documentation and discussing the request with the DNR's Ready for Reuse Program Manager, the DNR is approving the Funding Approval Request.

The Wisconsin Department of Natural Resources' (DNR) received the January 31, 2018 *Ready for Reuse Grant RRG-047 Funding Approval Request, Kenosha Engine Plant Operations & Maintenance 2018* (Funding Approval Request) that was prepared by AECOM Technical Services, Inc. (AECOM) for the former Kenosha Engine Plant (KEP) site. The Funding Approval Request is for the DNR to approve use of the Ready for Reuse Grant RRG-047 for operation and maintenance of the remaining groundwater recovery systems at the former KEP. Specific tasks include: i) performing routine and non-routine (in case of system shut down) monitoring and maintenance of the three groundwater recovery systems; ii) sampling the influent and effluent of the three groundwater recovery systems on a semi-annual basis; iii) preparing semi-annual reports of the influent/effluent sampling; iv) completing and documenting two rounds of groundwater sampling from 26 perimeter monitoring wells; and v) submitting the costs for vendor and utility services provided at KEP.

After reviewing and discussing the request with the DNR's Ready for Reuse Program Manager, the DNR is approving the Funding Approval Request.
