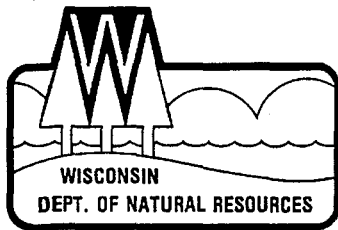

SUBJECT: Alleged Hazardous Substance Release at W124 N10014 Wasaukee Road,
Mequon, Wisconsin

Dear Mr. Rasmussen:

The Department has identified you, Peter Rasmussen, as a potentially responsible party that may have released a hazardous substance at Cermatics, Inc., W124 N10014 Wasaukee Road, Mequon, Wisconsin. This allegation is based on information obtained from Cermatics during its hazardous waste licensing and corrective action activities and from Department files. The alleged releases occurred when you were the owner of Ecolab, prior to October 1986. Ecolab shared the property with Cermatics. The purpose of this letter is: to make sure individuals know their responsibilities under the law and act accordingly; to explain what you need to do to investigate and clean up the contamination; to provide you with information about cleanups and environmental consultants; and to assist you in working cooperatively with the Department of Natural Resources.

This letter is being sent to you, Peter Rasmussen, as the potential responsible party, to notify you of your option to proceed with a voluntary cleanup under the NR 700 rule series. The rules found in chs. NR 700-728, Wis. Adm. Code, have been developed to provide direction and continuity in remediation of land and groundwater that has been contaminated by hazardous substances. Chapters NR 700-728, Wis. Adm. Code, establish requirements for the emergency and interim actions, public information, site investigation, design and operation of a remedial action system, and case close-out. Ch. NR 140 establishes groundwater quality standards, and Ch. NR 720 establishes procedures to determine soil clean-up standards. Investigation and remediation plans must conform to Department rules and must be implemented in a timely fashion. However, if you do not adequately address the alleged contamination without delay at the Cermatics property in compliance with the requirements of the NR 700 rules series, the Department reserves the right to proceed against you under the Wisconsin spill law or other applicable authorities.



Case Information:

Information obtained from Cermatics and from Department files indicates that PCB-contaminated wax was stored outside on the ground, in drums, and in trailers on the property shared by Cermatics and Ecolab when you were the owner of Ecolab. These drums remained on-site at least into 1989. Department sampling and inspections in 1987 indicate that some of the drums leaked, and an oily liquid was observed on the ground nearby. Also, a former Ecolab employee alleges that wax was buried in a trench adjacent to the building currently used for solvent storage. Further investigation is needed in several areas to determine the extent of the alleged contamination.

Steps to Take:

The longer contamination is left in the environment, the further it may spread and the more difficult it may be to clean up. To ensure that your investigation and cleanup comply with Wisconsin's environmental regulations, you should hire a qualified environmental consultant. These are the first steps to take:

- 1.) Within 2 weeks of the date of this letter, submit to the Department written verification (such as a letter from the consultant) that you have hired an environmental consultant. You will need to work quickly to meet this timeframe.
- 2.) Within 1 month of the date of this letter, your consultant must submit on your behalf a work plan and schedule for conducting the investigation. The consultant must follow ch. NR 716 and any other applicable administrative codes and technical guidance documents. You should include with your work plan a copy of any previously completed investigation or remediation work at the site in question.
- 3.) Keep the Department informed about what is being done at your site. You or your consultant must provide the Department with a brief report every 90 days, starting after the work plan is submitted. These quarterly reports should summarize the work completed since the previous report. Quarterly reports should include only a few pages of text accompanied by any pertinent maps, tables, and analytical results.

Please note that should conditions at your site warrant more frequent contacts with the Department, you will receive a letter from the Department spelling out the requirements for more frequent contacts or reporting. You will also receive one annual site status report form.

- 4.) When the site investigation is complete, your consultant must submit a full report on the degree and extent of contamination and a cleanup proposal (refer to chs. NR 722 and 724).
- 5.) All correspondence to the Department should be identified with the file reference information given in the upper right corner of first page of this letter: FID#246077260, Ozaukee County, RR file.
- 6.) Direct reports and correspondence to: John Kraehling, Environmental Repair Section

Hydrogeologist at the address stated in the above letterhead. The timeframe above allows you to hire an environmental consultant, develop a work plan, and implement the required work

more quickly than would be the case if a more formal action was initiated by the Department. The timeframe does not waive past or future violations.


Additional Information:
