Dear Mr. Markwell:

This letter is in reference to our telephone conversation on Nov. 1, 1996. At that time we discussed the mechanism for the transfer of the Corrective Action regulatory lead from the U.S. Environmental Protection Agency to the Wisconsin Department of National Resources at the above referenced facility. One way to accomplish the transfer is by a letter from the facility requesting a Class I Modification of the Federal permit to change the expiration date of the Federal permit to an earlier date. This may be justified if conditions in the State Conditional Modification to the Closure and Long Term Care Plan are equal to the Federal permit. A letter for such a request should include the following:

- 1. A statement that the request is being made pursuant to 40 Code of Federal Regulations, Part 270.42, Appendix 1.A.6. as a Class I Modification.
- 2. An explanation as to why the change is necessary. In this

case, the corrective action conditions in the State Conditional Modification to the Closure and Long Term Care Plans for Koppers Industries, Inc. dated September 20, 1995 and October 24, 1996 are equal to the conditions in the Federal permit. The Federal permit is thus no longer needed.

3. A request to change the expiration date of the Federal permit to the approval date of the Class I Modification.

Dear Mr. Tipton:

Pursuant to 40 Code of Federal Regulation (CFR), Part 270.42, Appendix 1.A.6, Beazer is formally requesting a Class I Modification of the Federal permit, issued to the Koppers Industries, Inc. facility located in Superior Wisconsin. Per our recent correspondences, the Class I Modification will be the mechanism used to transfer the Corrective Action regulatory lead from the United States Environmental Protection Agency (USEPA) to the Wisconsin Department of Natural Resources (WDNR), which received authorization in April 1992 to administer the Hazardous and Solid Waste Amendment (HSWA) portion of the RCRA program. Beazer also requests to change the expiration date of the Federal permit to the approval date of the Class I Modification. The following explains why the change is necessary as directed in 40 CFR, Part 270.42 (a)(i).

Beazer recognizes its obligation to address the facility through the applicable state and federal corrective action requirements. Beazer also believes that it is important to do so in a coordinated fashion that fulfills the corrective action requirements of each program and also protects against the unnecessary and wasteful use of resources through duplicative requirements. Because the conditions in the State Conditional Modification to the Closure and Long Term Care Plans for the KII facility, dated September 20, 1995 and October 24, 1996, are equal to the Federal Permit, Beazer requests that the Corrective Action regulatory lead be transferred from the U.S. EPA to WDNR.

I would appreciate your approval of this Class I Modification in writing prior to submittal of the Corrective Measures Study to WDNR, which is anticipated within 60 days following approval of the RFI (Fluor Daniel GTI, June 1997).
